CITIZENS' ADVISORY COMMISSION ON FEDERAL AREAS



BACKGROUND AND HISTORY

- Original Commission created by the Alaska Legislature in July 1981.
- Created primarily in response to ANILCA.
- Established as a temporary advisory agency of the executive branch of the state.
- Authorized until June 30 1988.
- Reauthorized in 1988 for 10 years and in 1998 for 5 years.
- Ceased operations June 30, 1999.
- Reauthorized by the Legislature in 2007.
- HB 87 established CACFA within the ADNR.
- Resumed operations in 2008.
- Commission sunsets June 30, 2014

Membership

- Composed of 12 members.
- Membership to represent each region of the state to give a geographical balance.
- Governor appoints 6 members.
- Speaker of the House appoints 1 member from the House and 2 public members.
- President of the Senate appoints 1 member from the Senate and 2 public members.
- Public members "shall be representative of the diversity of users and uses of federal land in the state."

Duties of the Commission Alaska Statute Section 41.37.220

- (a) The commission shall consider, research and hold hearings on the consistency with federal law and congressional intent on management, operation, planning, development, and additions to federal management areas in the state.
- (b) The commission shall consider, research and hold hearings on the effect of federal regulations and federal management decisions on the people of the state.
- c) The commission may, after consideration of the public policy concerns under (a) and (b) of this section, make a recommendation on the concerns identified under (a) and (b) of this section to an agency of the state or to the agency of the Untied States that manages federal land in the state.
- (d) The Commission shall consider the views, research, and reports of advisory groups established by it ...as well as the views, research, and reports of individuals and other groups in the state.

Suit

AS 41.37.240 The commission may request the attorney general to file suit against a federal official or agency if the commission determines that the federal official or agency is acting in violation of an Act of Congress, congressional intent, or the best interests of the state.

Agency Cooperation

 AS 41.37.250. Each state department, agency, board, and commission shall cooperate with the commission in the fulfillment of the duties of the commission under AS 41.37.220

Administrative

- Commission within the Department of Natural Resources
- Two staff members
- Staff is responsible to the Commission
- Office is located in DNR Northern Region in Fairbanks
- Minimum of 3 regular Commission meetings per year.
 (Anchorage, Juneau and Fairbanks)

Working Relationships & Consultation

- Submits comments & recommendations to Federal land management agencies.
- Provides Input to Governor and Legislature on Federal Land Management Issues.
- Commission operates independently from State ANILCA Program.
- Consults with ANILCA Coordinator and State agencies.
- Works with Congressional delegation on proposed legislation and other issues affecting federal public lands in Alaska.
- Consults with the public and interest groups to identify issues/problems.


ALASKA NATIONAL INTEREST LANDS CONSERVATION ACT

Section 17(d)(2) of the Alaska Native Claims Settlement Act directed the Secretary of the Interior to withdraw up to "...eighty million acres of unreserved public lands in the State of Alaska, including previously classified lands, which the Secretary deems are suitable for addition to or creation as units of the National Park, Forest, Wildlife Refuge, and Wild and Scenic Rivers Systems..."

Following the withdrawals, and 8+ years of studies, environmental impact statements, reports and recommendations by the Federal-State Land Use Planning Commission, public hearings, Congressional debate, and Monument designations, ANILCA was signed into law December 2, 1980.
