Analysis

The legislation amends AS 14.16.200, State funding for districts operating statewide residential educational programs and would take effect immediately under AS 01.10.070(c).

- --The legislation removes the limit for the number of residential boarding programs that may be approved by the department and receive boarding stipend reimbursement under AS 14.16.200.
- --The legislation provides that districtwide residential programs will qualify under AS 14.16.200.
- --The legislation allows for residential programs that are variable-length term.
- --The legislation changes the per pupil stipend rate from current law to 3X the current law.
- --The legislation amends the definition of a residential education program to be:
- "statewide or districtwide educational program means a public school for students in grades nine through 12 that provides education, room, and board for a variable-length term or full school year without regard to the student's district of residence."
- --The legislation adds a subsection that a district may cooperate with an Alaska Native organization or a nonprofit organization for the provision of room and board services to students enrolled in a residential program.

The calculations and fiscal note cost estimates respond to the three currently approved programs. Future programs that may be approved under the amended law are not included in the fiscal note cost estimate and adding programs, including districtwide and variable-term programs, would cause this annual cost to increase.

The residential program per pupil monthly stipend is paid for nine months, times the rate, times the actual count. Calculating the rate from 1x in law to 3x for the three currently approved statewide residential programs increases the cost by \$3,321.3 annually.

Since the law would take effect immediately, the stipend rates would increase for FY2013 and a supplemental would be required. Calculating the rate from 2x in law to 3x for the three currently approved statewide residential programs increases the cost by \$1,681.3 in FY2013.
