Dear Representative Olson,

I am writing you today to express my support of HB 74. I grew up in Fairbanks, have lived here for the past 54 years and raised my family here. I'm a pipefitter/welder by trade and currently the Business Manager of the Plumbers and Pipefitters UA Local 375 here in Fairbanks. As Business Manager I represent approximately 500 members and their families whom reside in the Fairbanks area.

As a homeowner, father (soon to be grandfather), representative of 500 working families and owner of a place of business (which includes two large training facilities) I can assure you that Fairbanks is in dire need of low cost, clean burning gas for space heating, electrical generation, usage of gas in the refining of crude (to produce gasoline, fuel oil, jet fuel) and any other use that will lower the cost of living in Fairbanks. Fuel oil is over \$4.00 per gallon currently and just the cost of space heating is a huge financial burden to the residents and businesses here. The high cost of heating oil is becoming very detrimental to the economy of Fairbanks.

During my life as a resident here in Fairbanks I've watched my parents, family and friends retire and remain in Fairbanks after retirement to be around family and friends. Due to the high cost of living here in Fairbanks, that trend is changing and more of the retirees, on a fixed income, are being forced to leave Fairbanks and the State after retirement. At what point does the cost of living in Fairbanks and/or Alaska drive young people, in the active workforce, to leave Fairbanks and/or Alaska to work for a lower salary elsewhere, if the reduction in the cost of living surpasses the salary reduction?

Many residents have turned to burning wood to heat their homes to offset the high cost of fuel oil. This practice is further deteriorating our air quality during the cold snaps and inversions we experience quite often in the winter months. There are many days that a poor air quality advisory is in effect which restricts activities for the elderly and folks with health issues.

I know that trucking LNG is not the most cost effective means of transporting natural gas but Fairbanks needs relief now and it sounds like HB 74 will give Fairbanks and the communities north of Fairbanks some relief until a plan to build an instate gas line is implemented. This bill would help get the distribution systems in place

and operational, so if and when an instate line is built the communities along the pipeline route are ready to use the economical gas immediately.
Thank you for your consideration of this very important issue facing the residents and businesses in the Interior of Alaska.
