NOTICE OF PROPOSED CHANGES IN THE REGULATIONS OF THE DEPARTMENT OF HEALTH AND SOCIAL SERVICES

BRIEF DESCRIPTION

The Department of Health and Social Services proposes to revise the grievance procedures relating to juvenile justice services and children's services.

The Department of Health and Social Services proposes to adopt regulation changes in Title 7, Chapter 54 of the Alaska Administrative Code, dealing with grievance procedures, resolution, and appeals relating to actions or inaction by the Division of Juvenile Justice or the Office of Children's Services, including the following:

- 1. 7 AAC 54.205 7 AAC 54.240 are proposed to be repealed. The content is being revised and relocated to 7 AAC 54.245 7 AAC 54.260.
- 2. 7 AAC 54.245, Juvenile Justice Grievance Procedures, is a proposed new section that outlines the grievance procedures for persons challenging an action or inaction by the Division of Juvenile Justice.
- 3. 7 AAC 54.250, Resolution and Appeals of Juvenile Justice Grievances, is a proposed new section that describes the departments role and the rights of the person filing the grievance in working towards finding a resolution or filing an appeal.
- 4. 7 AAC 54.255, Children's Services Grievance Procedures, is a proposed new section that outlines the grievance procedures for persons challenging an action or inaction by the Office of Children's Services.
- 5. 7 AAC 54.260, Resolution and Appeals of Children's Services Grievances, is a proposed new section that describes the departments role and the rights of the person filing the grievance in working towards finding a resolution or filing an appeal.
