FOR AN ACT ENTITLED

"An Act requiring the Department of Commerce, Community, and Economic Development to file an annual report to the Legislature regarding regional development organizations; extending the termination date of the Alaska regional economic assistance program; and providing for an effective date."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

* Section 1. AS 44.33.895 is amended by adding a new subsection to read:

(f) Not later than February 1 of each year, the department shall compile a report on the activities of regional development organizations that have received assistance under (a) of this section or a grant under (b) of this section. The department shall notify the legislature that the report is available. The report must include the information listed in paragraphs (1) - (3) of this subsection. To compile the report, the department shall require each regional development organization to provide the following information to the department on or before a date set by the department:
