HB 47 would add a new subsection to AS 09.40.230 to require a party seeking a restraining order, preliminary injunction, or staying a permit that affects an industrial operation to give security in an amount determined by the court for costs that may be suffered by the industrial operation if it is wrongfully enjoined or restrained, including an amount for the payment of wages and benefits for employees and payments to contractors and subcontractors of the industrial operation.	ng
