**A BILL**

**FOR AN ACT ENTITLED**

1 "An Act relating to the regulation of marijuana by municipalities; relating to  
2 marijuana; and providing for an effective date."

3 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

4 \* **Section 1.** AS 11.71.900(14) is amended to read:

5 (14) "marijuana" means all parts [THE SEEDS, AND LEAVES,  
6 BUDS, AND FLOWERS] of the plant (genus) Cannabis, whether growing or not, the  
7 seeds thereof, [; IT DOES NOT INCLUDE] the resin [OR OIL] extracted from any  
8 part of the plant, and [PLANTS, OR] any compound, manufacture, [SALT,]  
9 derivative, mixture, or preparation of the plant, its seeds, or its resin, including  
10 marijuana concentrate; "marijuana" [FROM THE RESIN OR OIL, INCLUDING  
11 HASHISH, HASHISH OIL, AND NATURAL OR SYNTHETIC  
12 TETRAHYDROCANNABINOL; IT] does not include [THE STALKS OF THE  
13 PLANT,] fiber produced from the stalks, oil or cake made from the seeds of the plant,  
14 [ANY OTHER COMPOUND, MANUFACTURE, SALT, DERIVATIVE,

1 MIXTURE, OR PREPARATION OF THE STALKS, FIBER, OIL OR CAKE, OR  
2 THE] sterilized seed of the plant that [WHICH] is incapable of germination, or the  
3 weight of any other ingredient combined with marijuana to prepare topical or  
4 oral administrations, food, drink, or other products;

6 Sec. 17.38.020. **Personal use of marijuana.** Notwithstanding any other  
7 provision of law, except as otherwise provided in this chapter, the following acts, by  
8 persons 21 years of age or older, are lawful and **are not** [SHALL NOT BE A] criminal  
9 or civil **offenses** [OFFENSE] under Alaska law or the law of any political subdivision  
10 of Alaska or **bases** [BE A BASIS] for seizure or forfeiture of assets under Alaska law:

11 (1) possessing, using, displaying, purchasing, or transporting  
12 marijuana accessories or one ounce or less of marijuana;

13 (2) possessing, growing, processing, or transporting **not** [NO] more  
14 than six marijuana plants, with three or fewer being mature, flowering plants, and  
15 possession of the marijuana produced by the plants on the premises where the plants  
16 were grown, except that not more than 12 marijuana plants, with six or fewer  
17 being mature, flowering plants, may be present in a single residence where two or  
18 more persons 21 years of age or older reside;

19 (3) transferring one ounce or less of marijuana and up to six immature  
20 marijuana plants to a person who is 21 years of age or older without remuneration;

21 (4) consumption of marijuana, except that nothing in this chapter  
22 **permits** [SHALL PERMIT] the consumption of marijuana in **a public place**; and

23 (5) assisting, **aiding, or supporting** another person who is 21 years of  
24 age or older in any of the acts described in (1) - (4) of this section; assisting under  
25 this paragraph does not include

26 (A) using, displaying, purchasing, or transporting

1 consume marijuana in a public place. A person who violates this section is guilty of a

4 (f) Nothing in this section prevents the imposition of penalties on [UPON]

28 by the municipality from the board of notice of the filing of the application. The board  
29 may not accept a protest received after the 60-day period, and, in no event, may a  
30 protest cause the board to reconsider an approved renewal of a registration. The board  
31 shall consider a protest and testimony received at a hearing conducted under (e)(1) or

1 (2) of this section when it considers the application or continued operation, and the  
2 protest and the record of the hearing conducted under (e)(1) or (2) of this section shall  
3 be kept as part of the board's permanent record of its review. If an application or  
4 continued operation is protested, the board shall deny the application or continued  
5 operation unless the board finds that the protest is arbitrary, capricious, and  
6 unreasonable.

7 (b) If the permanent residents residing outside of but within two miles of an

24 recommended by a municipality is imposed on a registrant, the municipality shall  
25 assume responsibility for monitoring compliance with the condition, except as

16 within the perimeter of the established village. A registration that may not be renewed  
17 because of a local option election held under AS 17.38.200 is void 90 days after the  
18 results of the election are certified. A registration that expires during the 90 days after  
19 the results of a local option election are certified may be extended, until it is void  
20 under this section, by payment of a prorated portion of the annual registration fee.

22 **election.** (a) If a majority of the voters vote to prohibit the operation of marijuana

26 prohibition on sale, purchase, and manufacture is effective beginning 90 days after the  
27 results of the election are certified. If there are no registered establishments within the  
28 established village, the prohibition on possession is effective beginning 60 days after

30 (c) A person who violates this section is guilty, upon conviction, of a class A  
31 misdemeanor. Each violation is a separate offense.

3 be conducted as required in this section.

5 residing within an established village, the lieutenant governor shall place on a separate  
6 ballot at a special election the local option or removal of local option that constitutes

22 within a five-mile radius of another site selected by the local governing body or by the  
23 board if the established village does not have a local governing body.

25 section includes any area that is within the perimeter of another established village  
26 and, if the other established village has

27                   (1) also adopted a local option under AS 17.38.200, the local option of  
28 the established village that is less restrictive applies in the overlapping area;

30 does not apply in the overlapping area.
