New Teleconference Bridge System Approval – ITB 612

Our existing teleconference bridge (Meeting Place) has served us well for the last 5 years, but the manufacturer (Cisco) has terminated the product line and will no longer offer any support for legacy systems. The services provided by the bridge are critical to connecting constituents and other callers to committee meetings. Without an operating bridge, we would not have teleconference capabilities available. Proceeding with a product that has zero support could mean a catastrophe in the middle of a busy legislative session with no timely resolution.

We have evaluated Sonexis, a comparable product that performs all of the functions that we needed from Cisco's Meeting Place. After in-depth review and use of demo accounts and product, ITB 612 was issued to obtain a low bidder (Arrow Systems Integration, \$84,154.57) for purchase and installation. In comparison, we purchased Cisco Meeting Place in 2010 for \$188,535.36. Since FY10, we have generated about \$50,000 of revenue from billing other state entities for using our services. The price of the annual service contract beyond the first year is \$10,185 which includes 24/7/365 support, and lifetime hardware & software updates & upgrades. The price of annual service renewals is guaranteed to never increase, provided the agreement never lapses. For comparison, the previous Cisco software-only service contract cost \$14,976 per year for Meeting Place.

Advantages with replacement

- Redundant, on-site hardware in the event of failure
- Will be supported by a service contract
- Perpetual license (free upgrades on software & hardware)
- Expedited work flow, ability to answer high call volumes faster
- Greater control over callers (interaction, moving between meetings)
- Caller ID & pre-identified phone lines

There is approximately a month lead time needed between approval and installation. In order to have adequate time to train and learn the new system, we would like to have approval of ITB 612 by Legislative Council at your next meeting and be able to proceed by November 15, 2015. This will ensure a smooth transition to the new product and our ability to seamlessly use it at the start of the 2016 regular session.

On October 2, 2015, ITB 612 was issued to solicit for a contractor to provide and install an audio teleconference bridge system. Six known vendors with the capability to provide and install the system were sent bids and the bid was published on the State's online public notices site.

ITB 612 closed on October 22, 2015. Three bids were received and opened from Arrow Systems Integration; Mission Critical Solutions; and Tactical Digital Corp. All bids met the requirements of the ITB. The bidder with the lowest total bid price was Arrow Systems Integration with a total price of \$84,154.57. A bid abstract is attached.

Based on the above information, I recommend award of ITB 612 to Arrow Systems Integration for a total price of \$84,154.57.
