Finance

- FY2016 dividend nearly tripled from \$7.5 million to \$19 million. FY2017 increased to \$25.9 million.
- Dividends/contributions made to State of Alaska totals nearly \$2 billion since 1986.
- Strong credit AA+ rating; recognized among the strongest housing finance agencies in the country.



Public Housing

- Mainly funded by U.S.
 Housing & Urban
 Development (HUD) for operating, maintaining & constructing low income housing.
- AHFC owns 1,011 family units, 610 housing units for seniors or those with disabilities; and distributes more than 4,300 vouchers in 13 locations* that provide rental assistance - \$2.7 million/month.

Mortgage Loan

In FY2015:

- Provided \$423.6 million to finance mortgages for more than 1,772 Alaskan families
 - first-time homebuyers
 - rural loans
 - veterans



Affordable Housing

FY2015:

- Leveraged resources (Rasmuson Foundation) to develop 24 units of housing for teachers, public safety and health professionals in rural Alaska.
- Funding for 180 units of affordable housing to be developed and upgraded benefiting low-income senior families and those with disabilities.
- Homeless assistance to 37 organizations in 20 communities benefiting 12,500 homeless individuals.



Energy Efficiency


Since 2008...

- 16 percent of housing stock 34 percent more energy efficient.
- Home Energy Rebates: 23,496 rebates averaging \$6,889.
- Weatherization: 16,594 homes complete through fiscal year-end.

Appropriations within the Department of Revenue (All Funds) (\$ Thousands)







(1,028.6)	. 30		In an effort to contain costs throughout the budget, the legislature asked AHFC to present a 3% and 8% reduction scenario. The 3% scenario was implemented. The expected impacts as a result include: Deletion of three PFTs (including the Director of Construction); lowering the steps of several PCNs; and reclassifying several positions for a total reduction to the Personal Services Line of \$771.4. The Construction Division has been reorganized to a Facility Management Group and the director position is no longer necessary. Information systems consulting services and maintenance contracts were also reduced by \$257.2. Delays may occur in certain project deliverables, but overall impacts should be manageable.
