7/91 – 6/12 President, Kawerak, Inc. - served as Chief Executive Officer for an Alaska Native Regional Tribal Consortium consisting of twenty member tribes. Kawerak's 200+ employees provide services to approximately 7,000 tribal members throughout our 26,000 square mile service delivery area.

10/90 – 7/91 Deputy Director of Kawerak. Administered personnel management function of Kawerak, oversaw financial management of programs, researched, developed and submitted proposals for funding, organized staff training and served as acting President in the absence of the President.

10/88 -10/90 Planner & Special Assistant to the Kawerak President. Program Planning responsibilities plus special projects assigned by the President.

6/85- 10/88 Program Development Specialist, Kawerak Inc., Nome, Alaska. Position responsibilities were similar to those outlined below.

I attended many many training sessions while employed at Kawerak, most dealing with personnel, wage and hour, conflict resolution, board training, ethics, group facilitation techniques, etc. I also helped set in place internal personnel systems including a comprehensive salary comp system (tied to employee performance evaluations), personnel policies and strong internal processes as they relate to personnel. An aside, we also set in place short and long range planning processes, strong accounting systems and policies, and greatly expanded funding, services and staffing. We also created a Kawerak and tribally owned for-profit road construction subsidiary.

During my time as Kawerak President, I served as the corporation's hiring and firing authority. Basically it was part of my job to insure we hired good people...and if we had problems with staff, the disciplinary process was set up to provide staff with notice of the problem, and to provide them with the time and opportunity to improve. If it was necessary to terminate an individuals employment, I insured that internal policies and state and federal laws were complied with prior to termination and the corporation was protected from lawsuits.
