


On behalf of the Canvas and the Sham Jam Planning Committee, I respectfully request that the Legislative Council sanction the 2016 Sham Jam event.

As you many know, Sham Jam is a longstanding event that offers staff, legislators, and residents of Juneau an opportunity to socialize, celebrate St. Patrick's Day, and give back to the community. 

The Southeast Alaska Foodbank is a 501 (c) 3 organization. Tax ID #92-0165056.


