HB75 amends AS 17.38 to refer to municipalities instead of local governments, and adds requirements for municipalities that have not already taken action related to the regulation of marijuana, to establish advisory boards. The bill also requires municipalities to designate a local regulatory authority that is responsible for processing applications submitted for registration to operate a marijuana establishment. The bill will require conforming changes to be made to the nine articles of marijuana regulations adopted by the Marijuana Control Board on 11/20/15 and which are set to take effect on 02/21/16.
There is no anticipated fiscal impact to the Alcoholic Beverage Control Board from this bill.
