

ADD: In is the intent of the Legislature that the work week for state employees including the court system should be 40 hours per week to reflect the non-government workforce, the private sector employees typically work a 40 hour work week.

EXPLANATION: It is understood the courts are stating that they are proposing a 4% pay reduction. It has been stated they want to close the courts on noon on Fridays and reduce the work week to 36 hours from 37.5 hours. However, after review, 37.5 divided by 1.5 equals 4%. Therefore, this is a net zero increase/decrease. This change may impact benefits using a reduced work week, or may potentially cost the state more because employees are receiving full time benefits for a reduced work week.

According to Article 4 sec 9 of the Alaska State Constitution the Judicial Council shall conduct studies for the improvement of the administration of justice, and make reports and recommendations to the Supreme Court and to the Legislature at intervals of not more than 2 years. It is the intent of this Legislature that the customer service surveys be sent to both the Legislature and the Judicial Council by 90 days after the close of the fiscal year.

EXPLANATION: Recommend the Immediate repeal SB 95 from 2014 (Rep Munoz Bill-there was an amendment submitted by the bill carrier initially which stripped the courts out of this bill). This bill gave non substantiated raises to all exempt employees in addition geographical differentials pay increases which were controversial. There is already an automatic step increase for nearly all state employees and often merit increases. During times of crisis it is not appropriate to give all employees automatic step raises, merit increases and cost differentials based on geographic differences. This will allow management to give merit raises based on quality work and on the good merits of an employee. Cola also needs to be evaluated. According to an email dated Feb 5, 2016 SB 95 cost the courts 4.2 million dollars last year. We need the 10 year projection for the cost of this controversial legislation for all departments including the court system. Cost savings measures must be put into place so we don't continue the fiscal death spiral. We must be able to provide for essential government services such as the courts if this crisis lingers so significant cost reductions need to be put into place immediately.
