# STATE OF ALASKA 2016 LEGISLATIVE SESSION

## BILL NO. SB 191

### Analysis

SB191 restricts an employee or affiliate of an elective abortion services provider from providing instruction on any topic or distributing material at a public school. The State Medical Board shall revoke or suspend the license of a physician, physician assistant, paramedic, or other licensee who violates this restriction. In addition, a person who violates this section of law may be fined five-thousand-dollars, or actual damages, and required to pay court costs and attorney fees to an aggrieved student or the student's estate.

The Division of Corporations, Business, and Professional Licensing does not anticipate fiscal impact from this legislation.
