#### FISCAL NOTE ANALYSIS

## STATE OF ALASKA 2016 LEGISLATIVE SESSION

BILL NO. HB 322

### **Analysis**

This bill limits the monthly salary that can be paid to exempt employees as defined in AS 39.25.110 to that of the Governor. Excluded in bill: president of the University of Alaska, president and three employees of the Alaska Gasline Development Corporation, petroleum engineers and petroleum geologists employed in a professional capacity by the Department of Natural Resources, justices, judges, and magistrates of the judicial branch, officers and employees of the Alaska Permanent Fund and the state medical examiner. Not excluded in bill: AS 39.25.110 includes "persons employed by the division of marine transportation as masters and members of the crews of vessels who operate the state ferry system and who are covered by a collective bargaining agreement provided in AS 23.40.040." Changes to salaries for these persons must be bargained. This bill allows the Governor to make case by case exception to this limitation if it is in the state's best interest. He is required to submit a report to the Legislature with the position description and recommended salary level. However, HB 322 does not indicate the next steps once the report is provided; it is unclear whether the Governor can move forward with recommended salary level or must first seek approval from the Legislature. For these reasons, the Division of Personnel submits an indeterminate fiscal note.
