Greetings Members of the Finance Committee:

I received at least 5 email acknowledgements back from employee at 511.gov that received my email. Where were they back in December. Where were they to try to fix my problem. I had to reach out several times for a cure. I was told my problem was sent on to the ones with the program for a fix. That didn't work. Then I was sent email instructing me on how to correct my problem. However, that did not work either. I reached out again and asked for a phone number to call in person and was told I could not talk to anyone as they were not state employees. They were contractors and I am sure they are paid quite well with State funds for this program which didn't seem to work or they didn't know how to fix. Finally, after many tries and contacts, I guess one of the contractors personally went into my account with 511.gov and fixed it. Really. Is this program – costing the state so much money – really worth it. Let me say that also here in the last week, I have received emails indicating their site was not working. On top of that, about 3 weeks ago, they actually put on the 511 gov website that one of our main highways was closed. That was not true. So my question to you is this: Is that website with a contractor being paid (I imagine huge amounts of money), really worth it? You need to look at this because as far as I am concerned, it should be trimmed back. What scares me is that is is only one example of waste.

YOU NEED TO CUT SCHOOLS AND HEALTH AND SOCIAL SERVICES and the unnecessary programs. And please, don't just send me back a note that you agree. I want to see and hear what you plan to cut.

Ever since pipeline days, the unneeded spending has gone on. The fish plant, the bridge by the port, the grain elevators, the ferry, the ag farms, the fancy schools out in the bush just to name a few I remember. And now the rail spur. And just think of how much those ag farmers we paid. The ag farms were to be for ag rights only so what happened. Not only did those people get STATE land but now they got about 2.8 million for the rail spur to be on the ag land. Talk about total absurdity. And no one is responsible for their actions or they blame the ones before them.
