FISCAL NOTE ANALYSIS

STATE OF ALASKA 2016 LEGISLATIVE SESSION

Analysis

The proposed legislation adds the commissioner of the Alaska Department of Military and Veterans' Affairs (DMVA) or his/her designee to the membership of the Council on Domestic Violence and Sexual Assault. The Council's mission is to provide safety for Alaskans victimized or impacted by domestic violence and sexual assault. It is responsible for ensuring Alaska has a system of statewide crisis intervention services such as local shelter programs, perpetrator accountability programs such as approved batterer's intervention programs, and prevention services.
The DMVA commissioner oversees several programs designed to prevent and address domestic violence and sexual assault in both civilian and military environments and would bring usueful perspectives to the deliberations of the Council. DMVA anticipates absorbing any expenses associated with carrying out the duties of this new position as a matter of fulfilling its multiple missions.
