It is unfortunate that today a law has to be written to define what a parents constitutional rights and responsibilities are. But that is where we are at in many areas, especially education.

I would like to note that when NCLB was in effect, a school district was required to notify parents who had children enrolled in a school, that had failed NCLB 3 years or more, that those parents had a right by State and Federal law to get their kids out of a failed school and enroll them in a successful school. The district was to provide at least 2 successful public schools which that parent could choose from. This was called public school choice.

However, in the ASD this public school choice was made extremely difficult by the Administration. It notified the parents of their options one day after the normal registration window closed. 



The original SB89 places rights into the legislature's hands, and once there, it's theirs to give or take. I think that key point is one that has been missed; it would create unintended consequences. These are rights currently in parents hands; amendments & wording in the original place them in the legislature's/state's hands by giving them authority to allow, provide for, grant, etc. exercise of those rights within parameters such as if it is harmful to the child. The parents would be left with the burden to prove harm. There is also a religious holiday exemption, but then parents are left having to prove their church/synagogue/etc. membership or present evidence from their family's holy book - this is what we are seeing unfold in other states. No parameters should be placed on these rights. The substitute is not a mere improvement, it saves parental rights regarding their children's education from being handed over to the state. Please preserve real parental rights by requesting the AACC Substitute.
