As an organization, our main points of concern are:


- A need for equal representation on the North Pacific Fisheries Management Council, Board of Fish, Advisory Panel and Stakeholders committees.

Dear Senator Bill Stolze and Committee Members:

The Alaska Trollers Association supports the confirmation of Robert Ruffner to the Alaska Board of Fisheries (Board).

The most essential ingredient of a solid Board process is the appointment of people who bring to the table a willingness to learn, combined with a shared vision of sustaining both fisheries resources and fishing communities. It is important for fishermen of all kinds that the Board is made up of people with first-hand knowledge of Alaska's fisheries and gear, but that's only one part of the equation. How they approach their task can make all the difference when it comes to successfully harmonizing the needs of each region. There are lots of ideas about what mix of people makes up a 'balanced' Board of Fish, but we contend it's not just a head count by gear type - with well over 150 fisheries around the state, that's an impossible goal. Board member 'attitude' is a huge component of successful Board outcomes and should not be overlooked.

Mr. Ruffner is an angler who has proven himself a consensus builder. He honed that people-skill while working to protect habitat and sustain Alaska's natural resources. Robert is familiar with Cook Inlet and the value of all fisheries to the social and economic health of the region and state. He has expressed a commitment to science; transparent decision-making; and, bridging diverse interests for the good of all. That kind of attitude is precisely what's needed on the Board, and far outweighs the wearing of any particular fishery stripe.

Chairman Stoltze, members of the committee, Alaskans

I've known Robert Ruffner professionally for more than 15 years. I've watched the Board of Fisheries processes for much longer. From my perspective, and from the perspective of the fish in this state, I think Robert Ruffner ranks among the best candidates for the Board of Fisheries that I've seen.

Robert Ruffner always has been an advocate for the rivers and streams and the fish that live in them on the Kenai Peninsula -- and beyond the Kenai. As an expert with a successful track record of protecting rivers and streams, I've known that people consult with him from around the state.

Robert is among the best candidates I've seen for three significant reasons: competence, integrity, and character.

Let me speak to competence. Robert's extensive experience in hydrology, fisheries science, and ecology uniquely qualify him for the Board of Fisheries. His broadband scientific skills will help all Board members constructively engage in the wide variety of issues from around the state that the Board addresses. He is a quick study.

Integrity. Robert's leadership on the Kenai Peninsula has been noteworthy for his numerous achievements on behalf of the river systems that enable Cook Inlet fisheries. My name is David Athons. I am and have been a continuous resident of the Kenai Peninsula since 1976. I am an avid sport fisherman and that is how I stock my freezer each summer. I retired from the Alaska Dept of Fish and Game, Division of Sport Fish, as a Fishery Manager in the Soldotna office in the year 2000.

I support Robert Ruffner for the AK Board of Fish and urge you to do so as well.

Over the last almost 40 years I have been an observer both personally and professionally of the politics of Fisheries Management and have watched it become increasingly polarized, often to the detriment of the resource. We respectfully agree with the Governor's appointment of Robert Ruffner to the Alaska Board of Fisheries (BOF).
