

On behalf of the Canvas and the Sham Jam Planning Committee, I respectfully request that the Legislative Council sanction the 2015 Sham Jam event.

As you many know, Sham Jam is a longstanding event that offers staff, legislators, and residents of Juneau an opportunity to socialize, celebrate St. Patrick's Day, and give back to the community. The Young Democrats, including many legislative staff, are responsible for the planning, promoting, and implementing of this charitable event along with the staff of the Canvas. This will be the 30th anniversary of the event, and most importantly, the proceeds support local charitable organizations.
