#### **MISSION**

#### What is Workers' Compensation?

A system of insurance that protects workers and employers from some of the losses caused by onthe-job accidents and job-related illnesses



## The "Grand Compromise"

An employer provides prompt, necessary medical and wage replacement benefits to an injured worker for a work-related injury.

In exchange, the injured worker receives limited benefits and gives up the right to sue the employer.



#### **Benefits Provided**

- Medical Care
- Indemnity (Wage Loss) Benefits
- Death benefits
- Reemployment (Retraining) Benefits



#### **How It Works**


**Employee Notifies Employer of the Injury**

#### **Workers' Compensation Requirements**

Any employer with one or more full or part-time employees must purchase and maintain insurance.




#### Failure to Insure

If an employer fails to insure as required by law, the employer may be subject to civil penalties.




#### **Alaska Injury Frequency**






#### **Alaska Claims Filed**





# **Total Compensation Payments**






#### **Program Challenges**
