Analysis

This bill would provide penalties and civil remedies for trapping or snaring within 200 feet of a campsite, recreational beach, roadside rest, scenic site, public trail, or other public facility. The bill would also require an identification tag be attached to traps. The Department of Natural Resources will absorb compliance costs within the normal duties of existing staff. These new trapping regulations would be added to the list of violations that Park Rangers look for during the normal course of their daily field work.
