The Alaska Professional Design Council (APDC) is a non-profit corporation in the State of Alaska, formed in 2004, to coordinate and complement the efforts of its professional design society members, especially in area of public policy and education. Our members are listed in the left column of this letter. These societies represent Engineers, Architects, Land Surveyors, Landscape Architects, and Interior Design professionals working in Alaska.

APDC appreciates and approves your efforts in sponsoring House Bill No. 48, an act relating to the composition of the State Board of Registration for Architects, Engineers, Land Surveyors, and Landscape Architects (Board); extending the termination date of said Board; and providing for an effective date.

The Board was created to administer the statutes and regulations related practices of Architects, Engineers, Land Surveyors, and Landscape Architects; and to comply with AS 44.62 (Administrative Procedures Act). Without extending the termination date, the Board will cease to existing putting the safe design practices of the State of Alaska at risk. Additionally, the Board includes one temporary, non-voting Landscape Architect. Considering the State Statutes include the profession of Landscape Architect, we support the provisions of the Bill, making this Board position permanent and voting.

Dear Representative Kito:

On behalf of the over 15,000 members of the American Society of Landscape Architects (ASLA), I write to express our full support for HB 48, which would extend the State Board of Registration for Architects, Engineers, and Land Surveyors (AELS) until 2025, and would institute a permanent voting seat for the board's landscape architect representative.

State licensing boards provide essential public health, safety, and welfare protections through the enforcement of applicable statutes and regulations. All 50 states regulate landscape architects, and of those with multidisciplinary boards, Alaska is the only state where the landscape architect representative(s) is not a permanent voting member. We firmly believe that a well-structured multidisciplinary licensing board should include permanent seats for the design professions regulated in the state. While throughout the past 17 years a landscape architect has participated as a nonpermanent, nonvoting member of AELS, this legislation would remove that barrier and provide a stronger, more effective voice for the landscape architecture profession, whose activities significantly affect the public, including:

- providing stormwater solutions that effectively manage water to minimize runoff, improve water quality, control erosion, and eliminate safety hazards
- creating designs—whether a streetscape, public plaza, campus, park, or playground—that safely coordinate all uses of a site to avoid injuries and reduce the threat of crime
- ensuring roads, parking lots, medians, and other transportation elements safeguard driver and pedestrian safety, are accessible to people with disabilities, and also provide environmental and community benefits.

Thank you for sponsoring this important piece of legislation. HB 48 makes crucial progress in protecting the health, safety, and welfare of the state's 740,000 residents and the 2,000,000 who visit annually.


The Alaska Chapter has been a professional non profit organization supporting Landscape Architecture in the State since 1978. Landscape Architecture is different than any of the other professions and the AELS board is aided by the input from the permanent voting Landscape Architect seat. Landscape Architects have been a licensed profession in the State since 1999. We have been a non-voting seat on the AELS board since licensure.

Having a Landscape Architect on the board as a permanent, voting member ensures that a professional landscape architect is available to provide guidance to the State as to what constitutes reasonable professional standard. This ensures that those who practice the profession have the technical expertise to avoid creating public health, safety and welfare issues.

The AELS board is fully funded through registration fees and, as professionals licensed in the State, Landscape Architects have paid licensing fees since 1999 and would continue to do so with HB 48. The change of a Landscape Architect to a permanent voting seat would not result in any additional cost to the State.

The Council of Landscape Architectural Registration Boards (CLARB) supports changing the Alaska AELS Landscape Architect's position from a non-voting to a permanent, voting position. This view is consistent with those expressed in several previous letters provided to your legislature during the past six years.

We believe that the public interest is best served through balanced and comprehensive representation of all regulated professions. Changing the position from a non-voting to a voting seat would allow all landscape architect registrants and applicants for licensure a direct link to the AELS Board and provide an active voice for these constituents.

AIA Alaska is a Chapter of The American Institute of Architects (AIA) representing and serving AIA member architects in the State of Alaska. AIA Alaska is a member organization of the Alaska Professional Design Council and represents and over 250 individual member architects, associates, and allied design professionals who are working in fields allied to architecture.

AIA Alaska appreciates and supports your efforts in sponsoring HB 48, Reauthorizing the Board of Architects, Engineers and Land Surveyors and making the existing Landscape Architect Position on the Board a permanent, voting position. HB48 extends the sunset of the AELS Board to June 2025. Landscape Architects have been licensed in the State of Alaska since 1999 and the Landscape Architect position has been temporary and non-voting for the last 17 years. Now there are almost as many registered Landscape Architects as Mining Engineers, a discipline with a designated seat. In addition, Landscape Architecture is different than any of the other disciplines and the Board is aided by the input from that seat. The AELS board is funded through registration fees and the Landscape Architect position on the board has been funded since 1999. This change would not result in any additional cost to the state.
