I am writing on behalf of the Alaska Oil and Gas Association (AOGA) to express our unequivocal support for HJR 5, which urges the United States Congress to pass legislation to open the coastal plain of the Arctic National Wildlife Refuge (ANWR) to oil and gas development. AOGA is a professional trade association whose members account for majority of oil and gas exploration, development, production, transportation, and refining activities both onshore and offshore in Alaska. AOGA's members are proud of our history of partnership with the State of Alaska and its citizens, endeavoring to provide revenue, economic opportunities, and infrastructure to the Arctic region. By affording Alaskans the opportunity to access the coastal plain of ANWR, we can ensure that that partnership continues unabated in the future.

Responsible development in the 1002 area of ANWR would provide an invaluable boost to America's energy security and bring much-needed economic growth to Alaska, at a time when it is desperately needed. Such access is also vital to ensure the long-term viability of the trans-Alaska pipeline.

ANWR has incredible potential for oil and gas, with government estimates placing the reserves at approximately 10 billion barrels. With an industry-wide Alaska hire rate of roughly 70%, these family-sustaining jobs would mostly serve to benefit Alaska residents, who would spend wages in our communities, boosting both the state and local economies.



Dear Co-Chair Josephson, Co-Chair Tarr & Members of the House Resources Committee:

I write to you today on behalf of Arctic Slope Regional Corporation (ASRC) in strong support of HJR 5, *Endorsing ANWR Leasing; Related Issues*. ASRC is owned by and represents the business interests of the Arctic Slope Iñupiat. Since opening enrollment in 1989 to Alaska Natives born after 1971, the corporation's shareholder base has nearly tripled, growing from the 3,700 original enrollees to around 12,000 today. ASRC owns approximately 5,000,000 acres of land on the North Slope.

Part of ASRC's land ownership includes 92,000 acres of subsurface estate on the coastal plain of the Arctic National Wildlife Refuge (ANWR). Together with the surface estate owner Kaktovik Inupiat Corporation (KIC), we represent the only major private landowners on the 1.2 million acre coastal plain. We are and have always been advocates for the exploration and development of the coastal plain of ANWR.

ASRC, Kaktovik and the North Slope Borough for decades have been solidly in support of leasing and exploration of the coastal plain of ANWR. We know collectively that exploration can take place with no harm to the environment. Only by leasing the coastal plain for exploration will we understand the location and quantity of resources to be found there. Part of this exploration would include the testing of the potential of the Native-owned lands near Kaktovik. We are currently prevented from developing these lands unless Congress acts.

ASRC supports HJR 5 not only because it is aligned with our mission to enhance Iñupiat economic opportunity while protecting subsistence freedoms for our region but it also provides economic stimulation and job creation for the entire state of Alaska and beyond.

ASRC has been and will remain committed to developing resources in a manner that respects Iñupiat subsistence values, protects culture and ensures proper care of the environment; the potential development in ANWR would be no different. The people of our region are dependent on subsistence hunting for our food, economic development for our infrastructure and for an improved quality of life in Alaska's harshest environment.
