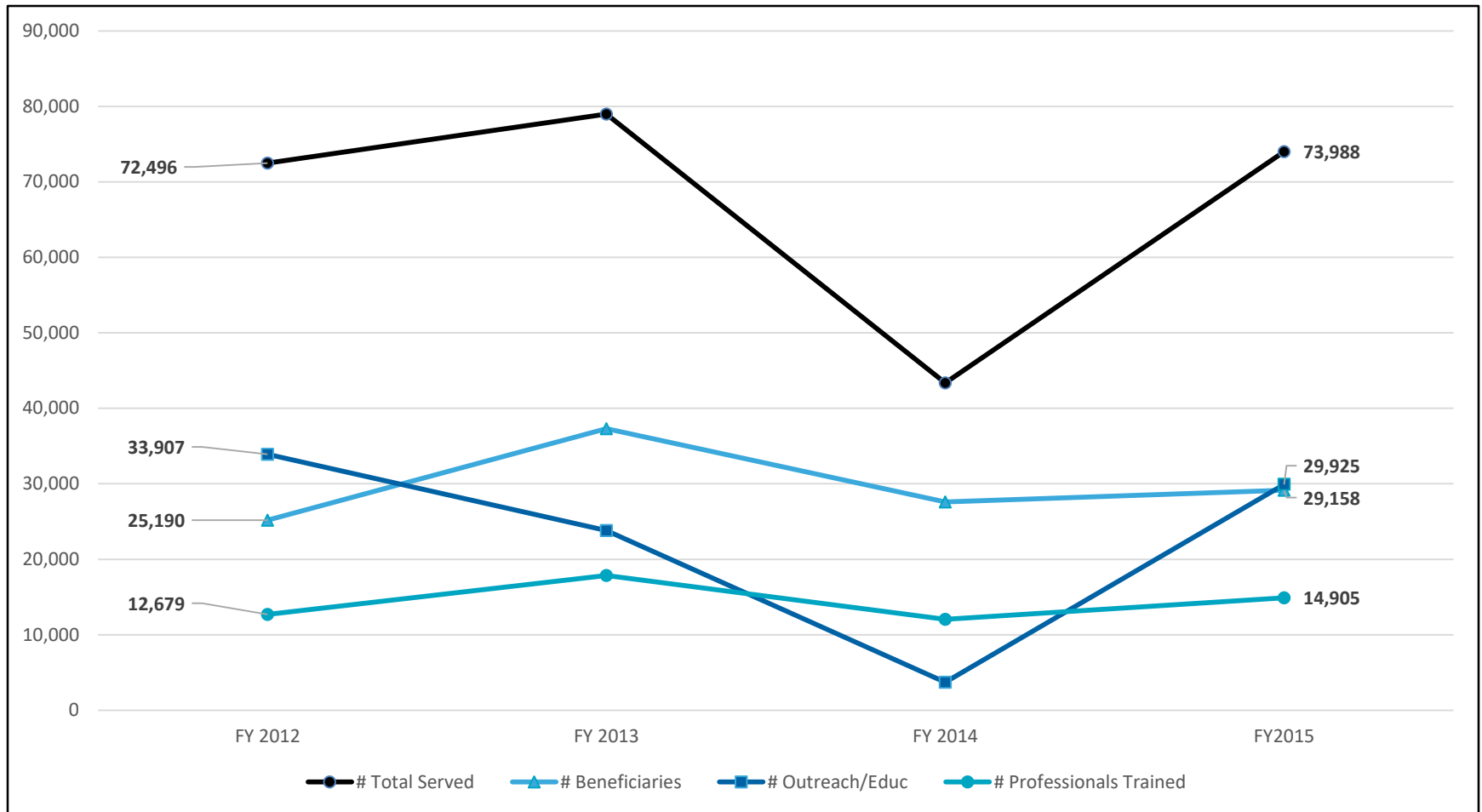

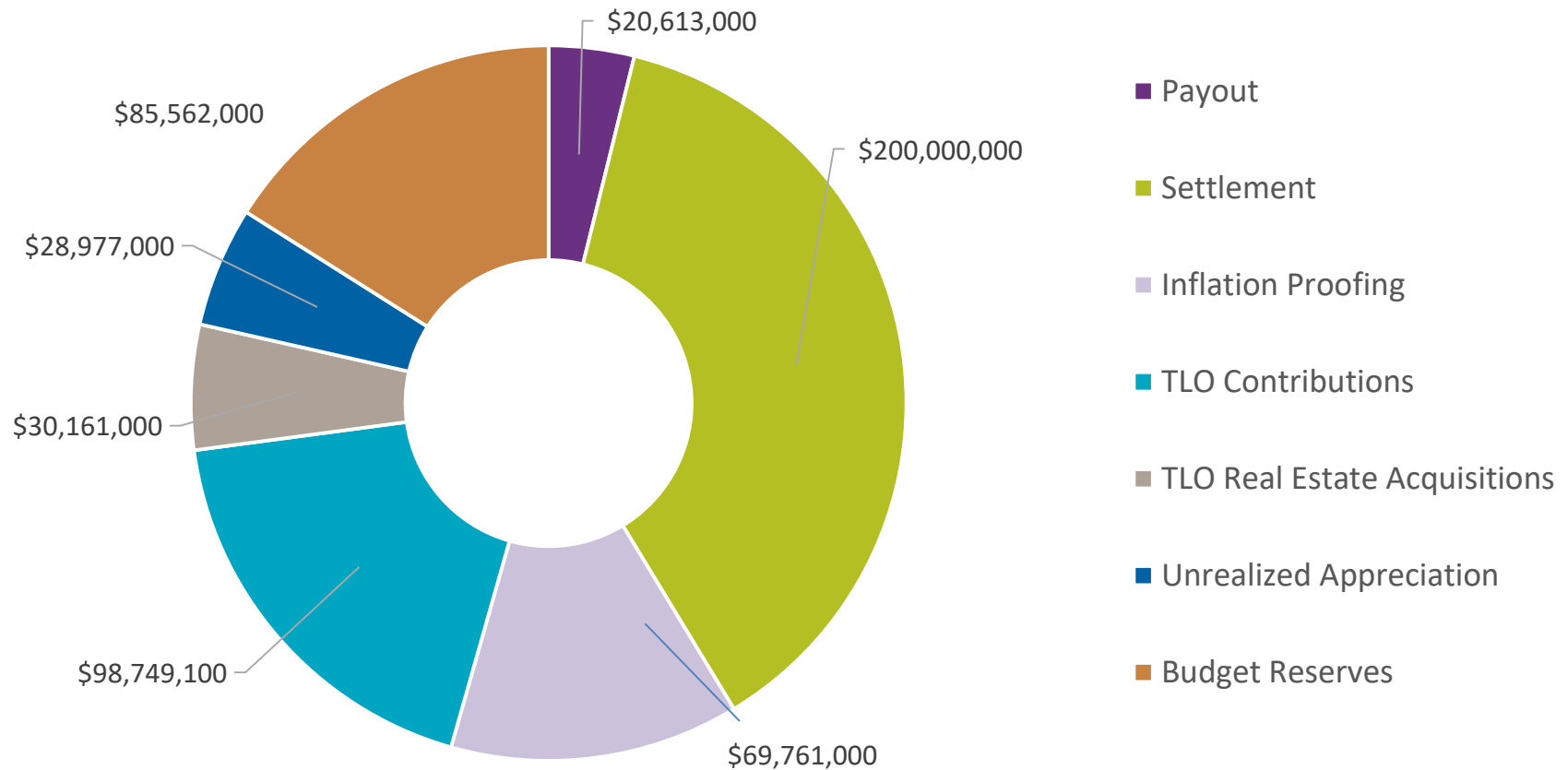

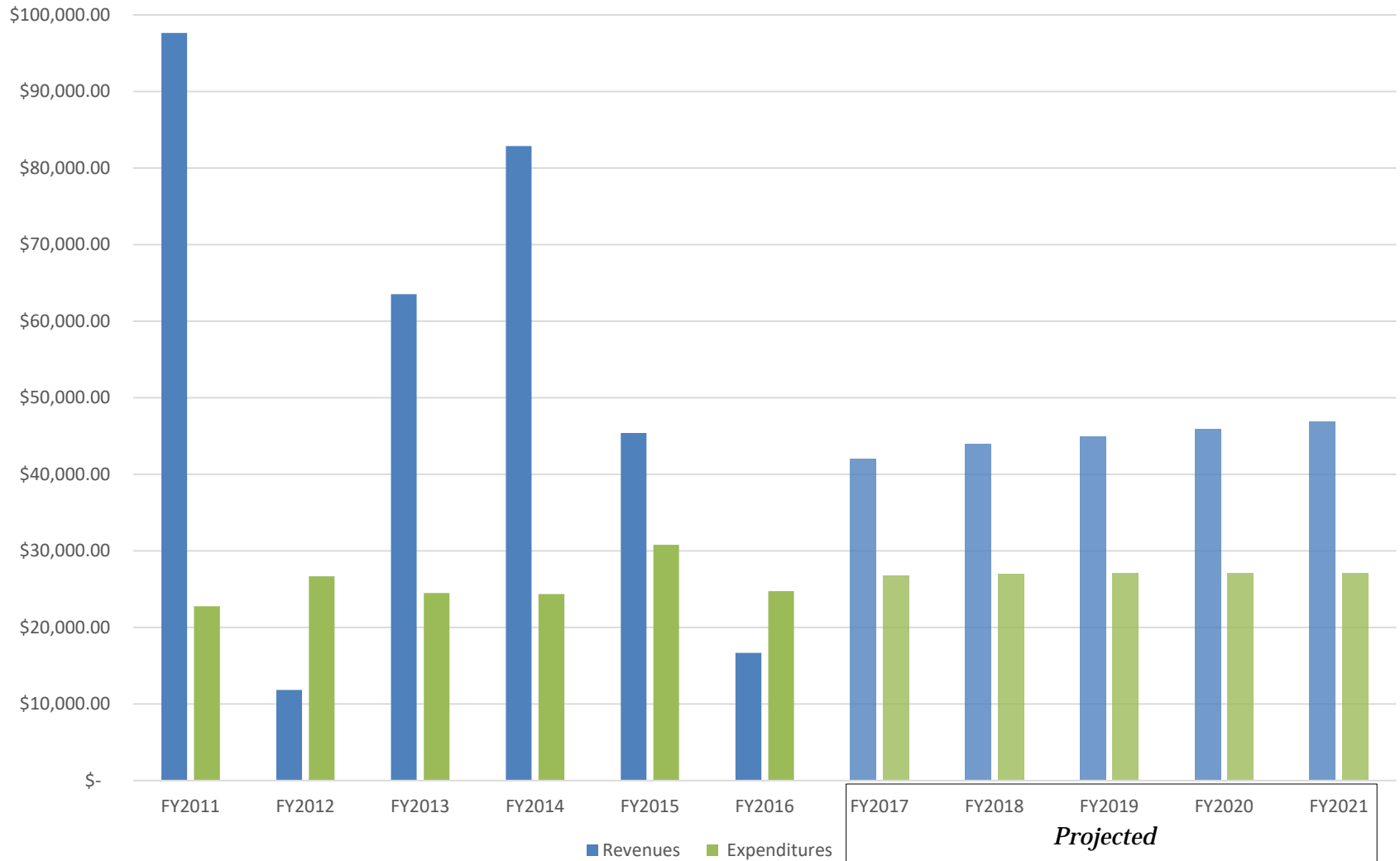


Cash Assets at End of FY16

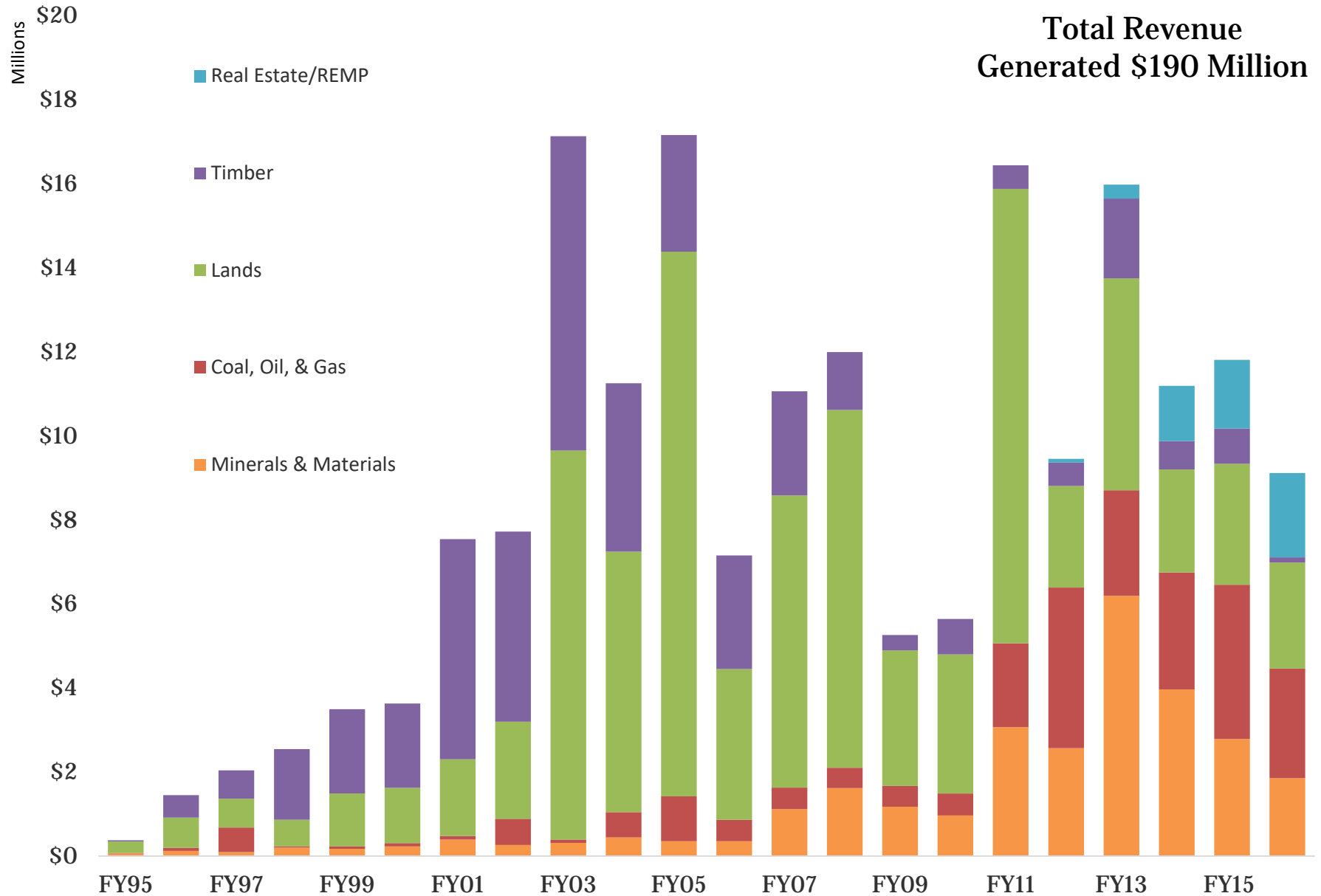


Revenues and Expenditures

Trust Land Office Annual Revenue

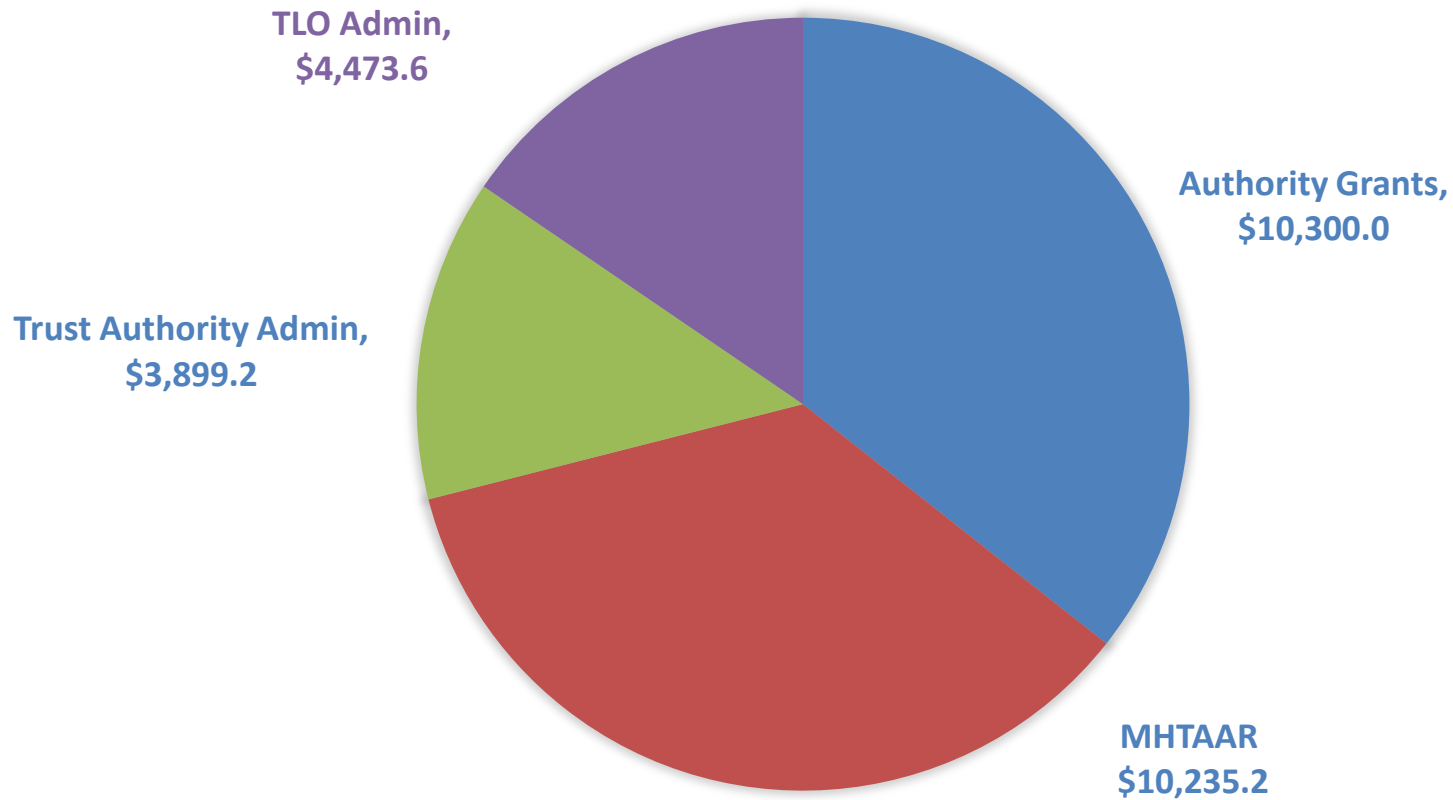

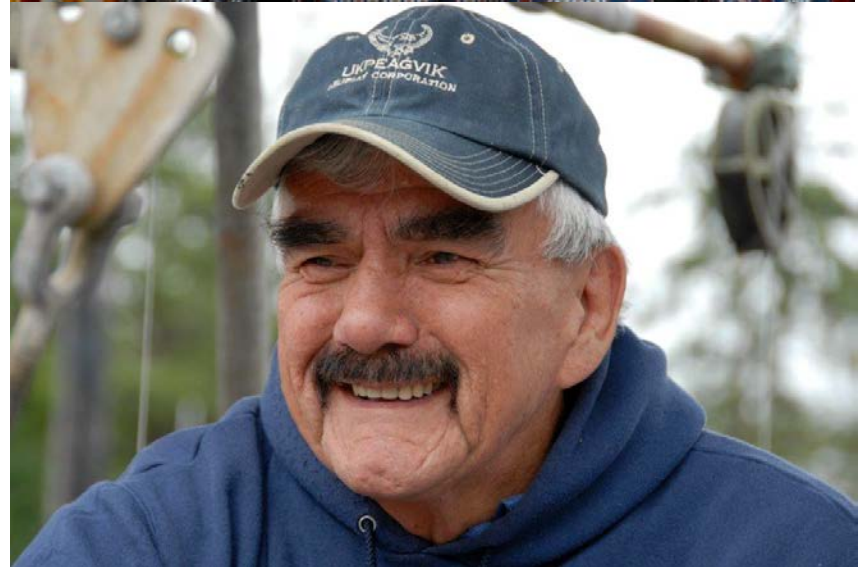

Core Services

- Resolve complaints to the satisfaction of the resident.
- Unannounced visits to all long term care facilities (nursing facilities and assisted living homes) that serve seniors.
- Educate residents and their families about their rights in a long term care facility.
- Provide information and referral about long term care services and facilities.
- Create systems change that improves the lives of residents of long term care facilities and older Alaskans.



- Residents of long-term care settings will be protected from poor quality of care, from violations to their rights, and practices which jeopardize their safety. In FY16 the LTCO:
 - Increased the number of visits to facilities from 434 to 740
 - 95% of the 662 complaints were resolved to the satisfaction of the resident
 - Increased the number of volunteers from 16 to 33 who made 199 visits to facilities
- Educate providers and the community about long-term care, the LTC Ombudsman Program and related issues including residents' rights. In FY16 the LTCO:
 - Staff provided consultation to 153 providers and 399 members of the public as well as provided community education at 39 events
