Medicaid

- Jointly funded by federal and state governments
- Safety-net for low income individuals
- Supplements Medicare coverage for dual eligibles
- States must offer Mandatory Services AS 47.07.030 (a)
- States can offer Optional Services AS 47.07.030 (b)
- States can offer Waiver Services AS 47.07.045

Medicaid Services

Medicaid Component	Covered Services
Behavioral Health Medicaid	Mental health clinics, substance abuse clinics, psychiatric physicians, residential psychiatric treatment centers, and inpatient psychiatric hospitals. Behavioral rehabilitation services for children.
Health Care Medicaid Services	Inpatient and outpatient hospital services, physician services, pharmacy, transportation, dental, vision, laboratory and X-ray services, physical/occupational/speech therapy, chiropractic, medical equipment, home health, hospice, and state-only Medicaid benefits. Other activities supporting direct services delivery include providing Medicare premium assistance for dual eligibles, recovering third-party liability payments, and making supplemental (disproportional share, or DSH) payments to hospitals.
Adult Preventative Dental Medicaid Services	Preventative and restorative dental services for adults.
Senior and Disabilities Medicaid Services	Nursing home and personal care services. Home and community based waiver programs for children with complex medical conditions (CCMC), individuals with intellectual and developmental disabilities (IDD), Alaskans living independently (ALI), and adults with physical and developmental disabilities (APDD).

EPSDT

Children's Services

If a Medicaid eligible child is determined to need treatment, all medically necessary health care services must be covered.

- If it is within the scope of mandatory or optional services under Federal law.
- Regardless of whether those services are included in that State's plan.
- Does not include waiver services.

Optional Services

(Selected by the Alaska Legislature for coverage in AS 47.07.030(b))

- Case Management Services
- Chiropractic Services (not in regulation)
- Clinic Services
- Dental Services (includes dentures)
- Durable Medical Equipment Services
- Substance abuse treatment (under rehabilitation)
- Emergency Hospital Services (for non-enrolled hospitals)
- End Stage Renal Disease (ESRD) Services (under clinic)
- Hearing Services
- Hospice Care
- Intermediate Care Facility / Intellectual and Developmental Disabilities

Optional Services (Continued)

- Inpatient Psychiatric Services
- Licensed Clinical Social Workers (not in regulation)
- Medical Supplies
- Mental Health Services (under clinic and rehabilitation)
- Nutrition Services for pregnant women

Optional Services History

- AS 47.07.067. Payment for adult preventative dental services - Sec. 2 ch 52 SLA 2006,
- AS 47.07.030(b). Since 1994, no services added, only refinements to case management coverage or inclusion of school based services
- In FY 1995, some optional services were suspended. Services were restored in FY 1998.

Access

 Optional Services can expand the providers available to see Medicaid enrollees.

 Example, Community Mental Health Clinics offer an alternative to Physician Mental Health Services.

ADA Compliance

- Providing Medicaid recipients with services in the most integrated settings.
- Home and Community-Based Services, Personal Care, Rehabilitative Services provide alternatives to institutional care.
