Aleutian Pribilof Island Association Office Building - Anchorage, Alaska

Architect-of-Record: The APIA office building is a three-story, 38,700 SF project located in the heart of Anchorage on a beautifully wooded site with Campbell Creek running through it. The design of the building stems from the traditional visor worn by the Aleut hunters that is penetrated with modern program elements. The atrium and lobby areas allow for large gatherings and celebrations that can spread to the exterior deck which is surrounded by existing vegetation. An Aleut heritage library and studio on the first floor will display Native artwork and traditions as well as provide a place for artists to go to create their work. Artifacts and photographs will be displayed throughout the public areas of the building to share and educate visitors about their heritage.

Afognak Native Corporation Alutiiq Center - Anchorage, Alaska

Architect-of-Record: The Alutiiq Center is the Anchorage offices of the Afognak Native Corporation and its subsidiary, Alutiiq LLC. The design incorporates the display of Native artwork and cultural information. The building and site design of the five-story structure draw inspiration from images of Afognak Island and the region of the Alutiiq people. Geographic elements are

reinterpreted in a contemporary design that exemplifies this native corporation's place on the cutting edge of technology in the business environment. Size: 71,000 SF building served by a 56,000 SF two-level parking structure.

Alaska Regional Hospital Master Planning - Anchorage, Alaska

Architect-of-Record: Master planning for hospital campus with its multiple projects includes complex renovations, building systems, and specialty systems, as well as project management. Ongoing work includes space planning for medical offices, tenant improvements, and new facilities in a design/assist capacity.
