Removed a failed HESCO wall section, shaped, and imported sand for a sand fill layer. Sewed and placed geotextile fabric. Placement of core rock, “B” and “A” rock. Option 1 required mining and hauling sand from a material site to designated areas in front of another section of HESCO sea wall to mitigate further erosion until future options could be built. The subsequent options that were awarded for this project added LF to the rock revetment for a total of 2,000LF and a total contract amount of \$15.3 million. This project was completed on-time and under budget and received not only a letter of recommendation from the USACE but also a CCAS rating of OUTSTANDING.

Construction activities included; Construct of a standard design Multipurpose Machine Gun (MPMG) Range consisting of ten lanes. Primary facilities include the MPMG range, site development, ammunition breakdown building, bleacher enclosure, range operations and storage building, covered mess and building information systems. Supporting facilities include information systems and all target emplacements. Brice Incorporated was the heavy civil subcontractor on this project and had to clear approx. 280 acres as well as perform 133,500CY of excavation, 205,750CY of unclassified fill, 14,750 CY of classified fill and 4,750CY of surfacing material.
