FISCAL NOTE ANALYSIS

**Analysis**

This bill amends AS 29.71.040(a and b) to increase Alaska agricultural and fisheries product preferences from 7 to 15 percent. An increase to preference percentage has no anticipated impact on the Division of General Services, Purchasing component.

This bill amends AS 03.05.010 to allow the commissioner of the Department of Natural Resources to sell merchandise and issue licenses related to the "Alaska Grown" trademark and collect fees for those transactions. The commissioner shall sell merchandise that is produced/manufactured (printing, screen printing and embroidery) in the United States, that under AS 36.30 is procured from either an Alaska bidder or a person that employs prisoners under AS 33.30.191(b), to the extent practicable. This amendment has no anticipated impact on the Division of General Services, Purchasing component.
