TVEP Purpose and History

Purpose:

To enhance the quality and accessibility of job training across the state, and align training with regional workforce demands



Background:

- Established by the Legislature in 2000
- Funded by a portion of employee contributions to unemployment insurance
- Distributed to technical and vocational education entities across Alaska in accordance with statute





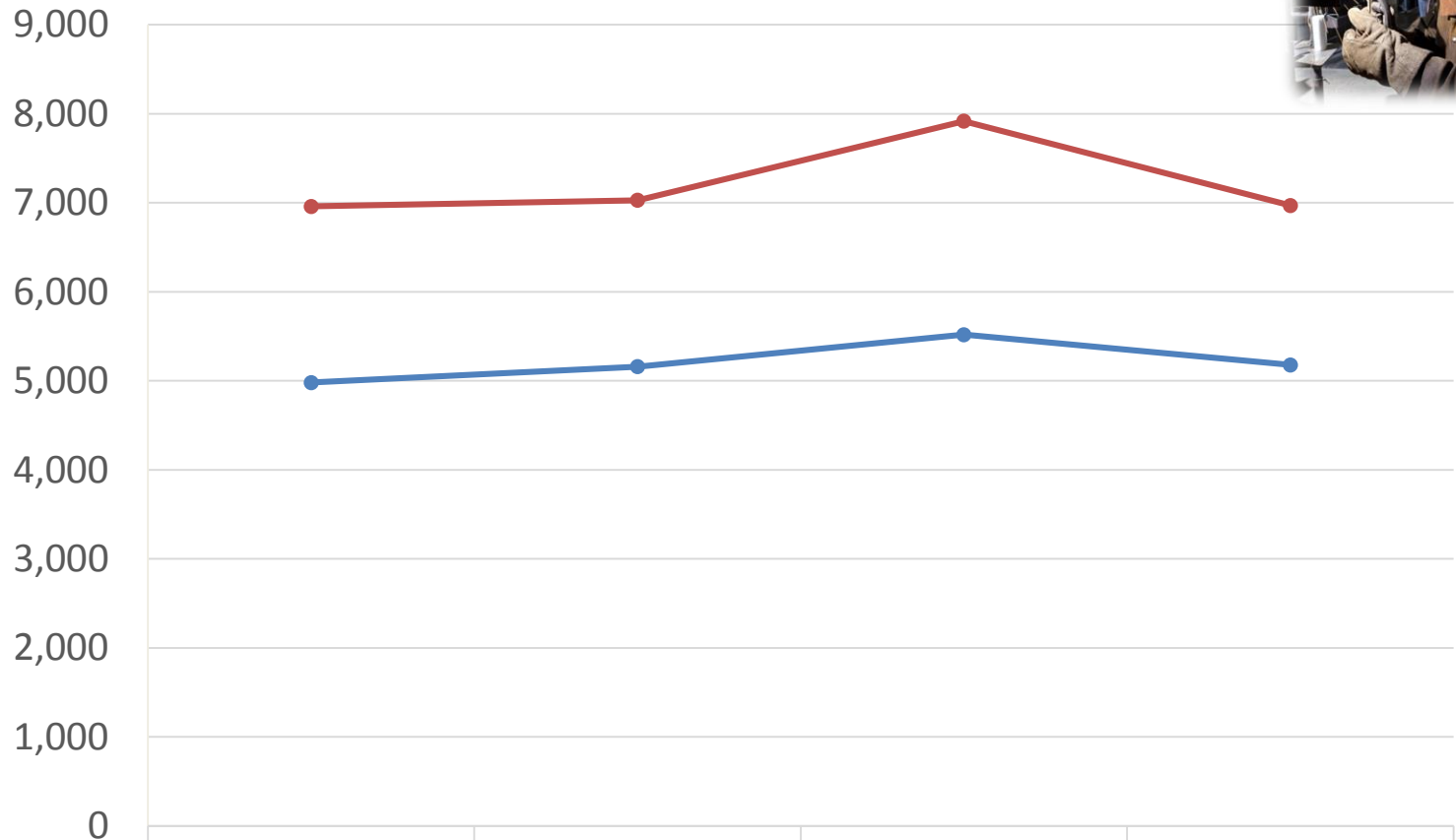
TVEP Overview

- Serves youth and adults
- Ensures a statewide training infrastructure
- Supports operating costs for training centers across the state, including rural Alaska
- Provides a wide range of vocational training from entry-level to associates degrees
- In FY2016, served 10,295 Alaskans at a cost per participant of \$1,215
- Effective in increasing graduation rates, employment and earnings, and Alaska resident hire; and reducing unemployment

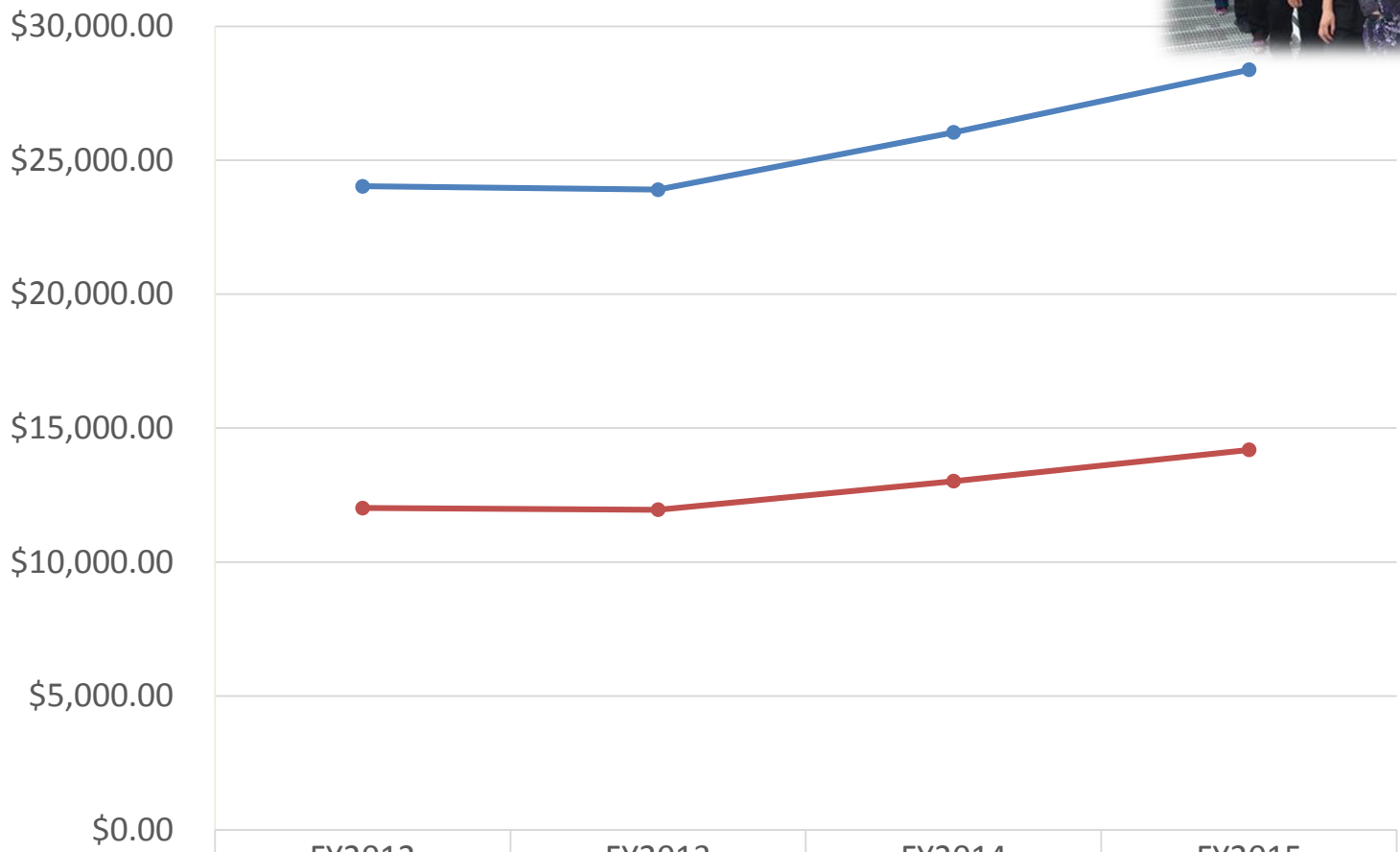

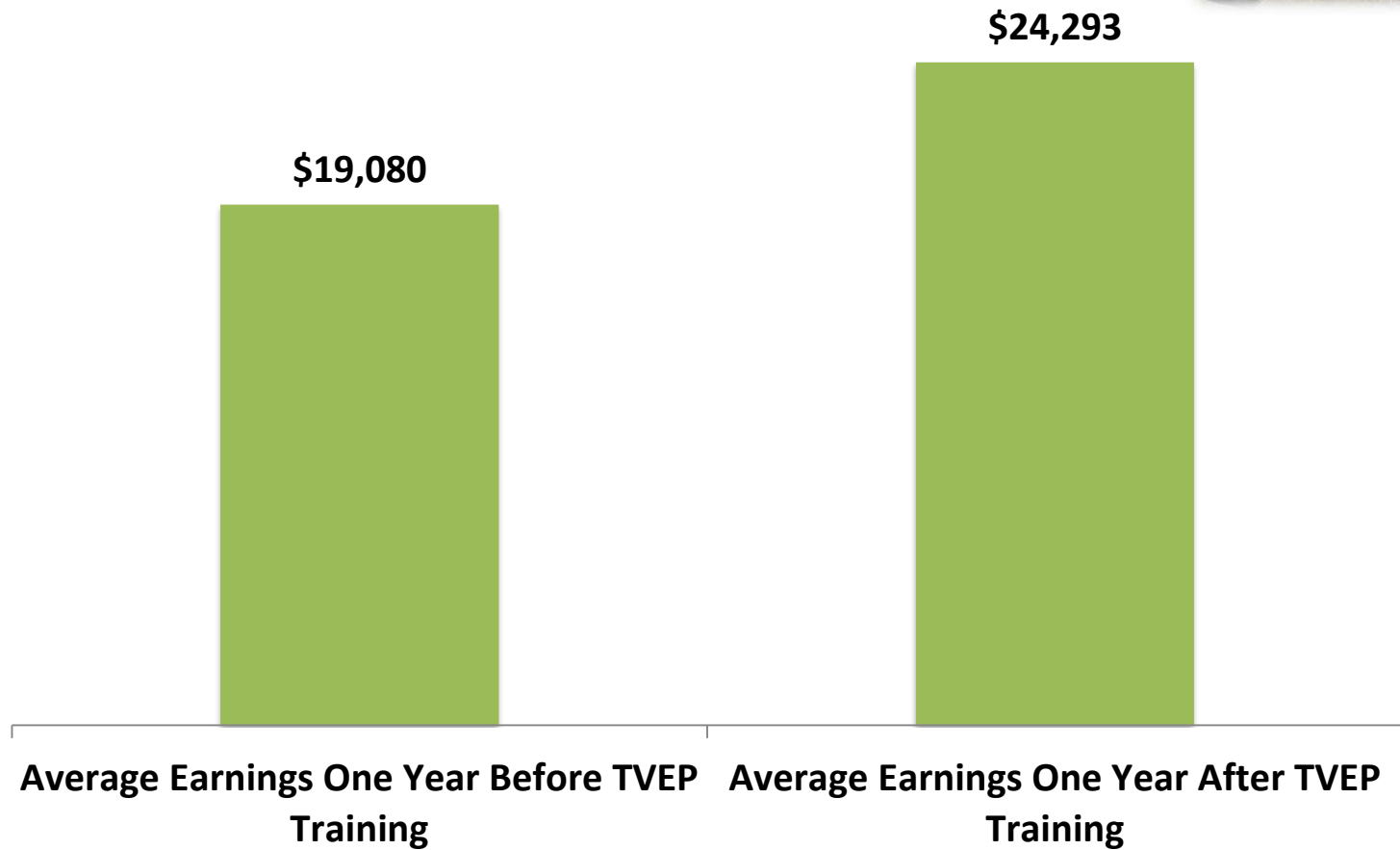

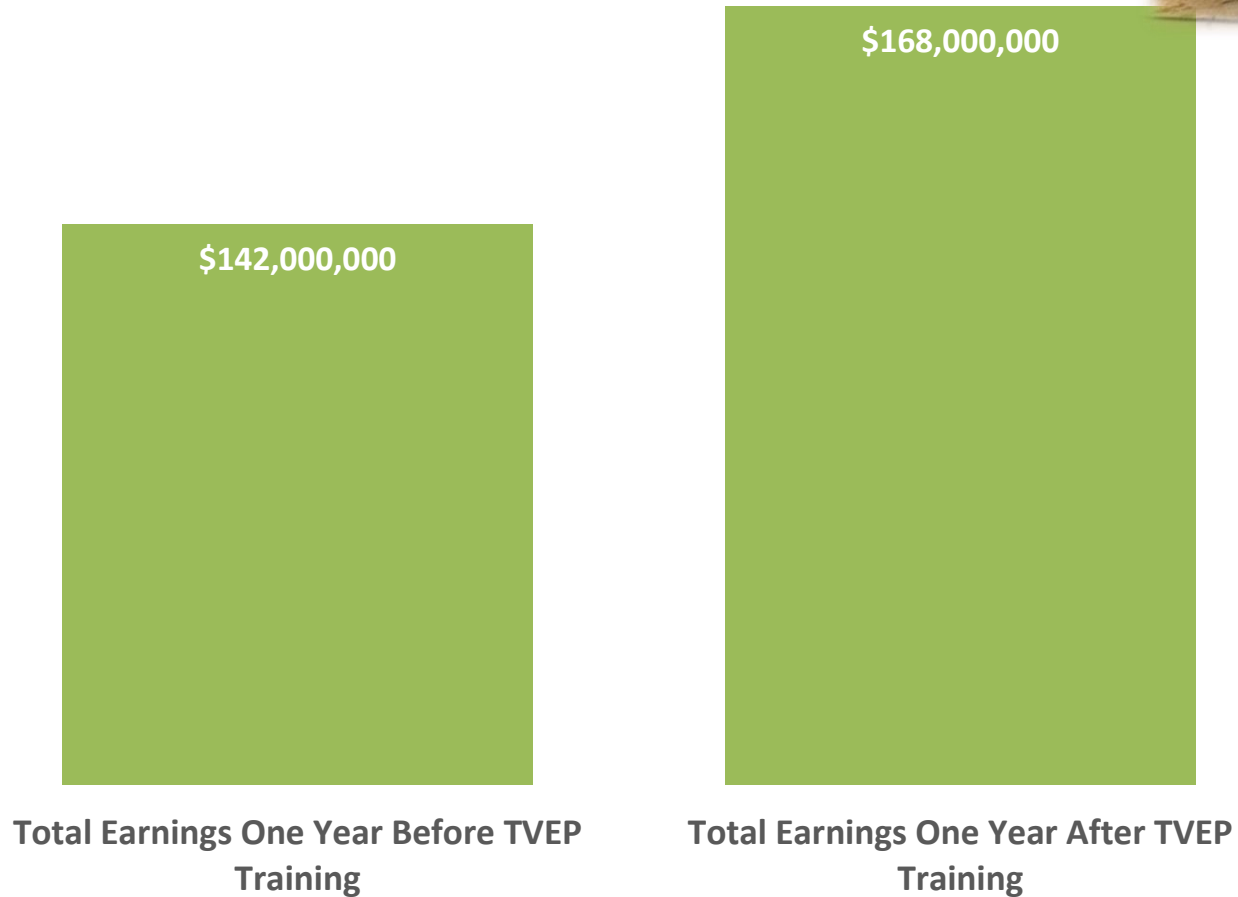
