Dear Senator Coghill: By way of some background, I am an American of Yup'iq descent, from the Native Village of Akhiok, on the South end of Kodiak Island. I have served in leadership positions from prior to and post ANCSA corporations: During the RurALCAP, Inc. operations, I began as a Village Aide, assisting Tribal Councils in their administrative and governance works; I was elevated to the position of Assistant Director, under Executive Director, Larry Brayton. This position took me to many of Alaska's regional transportation and communication hub areas. Following RurALCAP, I was awarded a fellowship with the National Urban Fellows program out of Yale University. Under this fellowship, I worked as Special Assistant to Congressman Nicholas Begich in his Washington, D.C. office on the Hill. Following my RurALCAP experience, I was retained and worked as Assistant Health Director with the Alaska Federation of Natives, Inc. under Health Director Carl Jack of Kipnuk, Alaska of the Bethal area. I also served as Executive Director and Presiding Officer of the Kodiak Area Native Association and following this experience, served two terms as Director with the Koniag, Inc. Regional Native Corporation.

Jahna Lindemuth must not be confirmed as Alaska's Attorney General. I am a close friend, an associate and colleague of Mr. Frank Pagano, a Koniag shareholder and past Director and Presiding Officer of his village corporation, Leisnoi, Inc. and Koniag, Inc. Likewise, I am a friend, a colleague and an associate of CIRI shareholder, Robert Rude. Each of us have been sued, marginalized and sanctioned by our respective regional ANCSA corporations under Alaska's regulation 3AAC 08.315 False or Misleading Statements. However, on Mr. Pagano's and Mr. Rude's situation, they both have been sued by their corporations, Leisnoi, Koniag and CIRI as well, with attorney Jahna Lindemuth as the primary litigator.

As stated in Mr. Pagano's letter to you, Ms. Lindemuth has colluded with other attorney's as well as with Superior Court Judge Frank Pfiffner to financially rip off Leisnoi of over \$2 million in purported legal fees. Ms. Lindemuth, on behalf of her Leisnoi and CIRI clients has taken advantage of our Native ANCSA corporations. Ms. Lindemuth has also had certain damaging and revealing email exchanges of her Leisnoi clients place under seal by Superior Court Judge Easter, which evidence would prove her guilt as a corrupt attorney...and violator of her attorney rules and regulations.

I request and urge you and your Committee to NOT recommend confirmation of Ms. Lindemuth as Alaska's Attorney General until you have examined her background and record of her conduct and behavior as an officer of the law! Ms. Lindemuth has a seriously tainted and blemished record which should disqualify her for the position of Attorney General.
