FISCAL NOTE ANALYSIS

BILL NO. HB 6

Analysis

The bill explicitly confirms that the current responsibilities, activities and authorities of the commissioner of the Alaska Department of Fish and Game (ADF&G), the department, and the Alaska Board of Fisheries and the Alaska Board of Game are retained with the creation of the Public Use Area. Responsibilities include management and enhancement of all fish and wildlife and noted certain game species. Activities include fisheries and wildlife management and research and habitat enhancement as well as access to conduct those activities. Authorities include the regulation of fish and game resources resting with the commissioner and boards. The bill does not add additional duties or responsibilities to ADF&G, therefore the department does not anticipate a fiscal impact.
