FOR AN ACT ENTITLED

1 "An Act relating to criminal law and procedure; relating to controlled substances;
2 relating to sentencing; relating to protective orders; relating to restitution; relating to
3 the period of probation; relating to revocation, termination, suspension, cancellation, or
4 restoration of a driver's license; relating to parole; relating to the duties of the
5 Department of Corrections and the Department of Health and Social Services; requiring
6 an inventory of and reports on untested sexual assault examination kits; and providing
7 for an effective date."

8 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

9 * **Section 1.** AS 11.46.280(d) is amended to read:

10 (d) Issuing a bad check is

11 (1) a class B felony if the face amount of the check [, ADJUSTED
12 FOR INFLATION AS PROVIDED IN AS 11.46.982,] is \$25,000 or more;

13 (2) a class C felony if the face amount of the check, adjusted for

inflation as provided in AS 11.46.982, is \$1,000 or more but less than \$25,000;

(3) a class A misdemeanor if the face amount of the check, adjusted for inflation as provided in AS 11.46.982, is \$250 or more but less than \$1,000;

(4) a class B misdemeanor if the face amount of the check, adjusted for inflation as provided in AS 11.46.982, is less than \$250.
