Dear Representatives Josephson & Tarr,

I want to let you know how disappointed I was today when I went to the Fairbanks LIO to testify in front of your Natural Resources Committee on HJR 5.

I arrived early & was fifth on the list.

After a considerable delay your committee finally started allowing testimony. Six people testified from Anchorage, then they started with Fairbanks.

After waiting two hours, testimony was cut off right in front of me. Let me assure you there were 20 other people in that room that were at least as angry as I was.

Some other method of recording testimony needs to be allowed so that people don't feel like their time was wasted. A lot of people just gave up & left even before testimony was halted.

State legislators don't understand how much opposition there is to opening up the Arctic Refuge to oil development. Even here in Alaska there are thousands of people that feel we need to make a stand and not allow oil development in our nation's treasures.

These areas have been set aside to protect what makes Alaska such a special place to live. Why is it that our leaders always want to destroy what makes Alaska so special.

The state legislature needs to drop these two resolutions. There are other areas west of Prudhoe Bay that are far less controversial that can be developed to help fill our pipeline.

The petroleum industry already has access to most of the rest of north slope of Alaska, or it is being opened up as we speak. (That's 95% of the north slope.)

It is highly unlikely that I will be able to testify in front of the committee again next week. I have other commitments, as I did today. I cannot afford to waste my time when it doesn't seem to matter anyway.

I appreciate our public servants, including our politicians. You all work very hard. I assume this wasn't anyone's fault, although it certainly looked like it was intentional.

People want their legislators to listen to what they have to say on these issues. When they take time off from work, or from their busy schedules, and then get cut off from testifying they have a right to be disgusted with the process.

This discourages democracy.

I urge state legislators to drop both these divisive resolutions. Let's concentrate our time on developing our resources in areas that are less controversial.

Dear Representatives,

Find attached a slide show I put together from my 40 years of leading wilderness trips into & across the coastal plain of the Arctic National Wildlife Refuge.

I have led hundreds of Alaskans as well as people from all over the world on rafting, backpacking & nature trips to this very special area.

I am one of several dozen Alaskan companies that operate hunting, fishing & wilderness travel trips in the Arctic Refuge.

This area is not only a national treasure, but it a treasure to many Alaskans.

The coastal plain is the heart of the Refuge. This is where we see most of the wildlife. Without the coastal plain the Arctic Refuge would just be mountains.

There is nowhere on Alaska's north slope where you can float out of the mountains, across the coastal plain to the Arctic Ocean in such a short distance. Everywhere else it is at least a hundred miles or more from the mountains to the sea.

I and my clients have witnessed tens of thousands of caribou crossing rivers such as the Hulahula, Okpilik, Jago & Aichilik. We have seen the bands of musk oxen that make the coastal plain their home. Each year we witness hundreds of thousands of birds that migrate to the coastal plain from most continents of the world to breed, rear their young & rest.

As has been proven at least several times this winter there are areas west of Prudhoe Bay that are far less controversial, that we can develop to add more oil to our pipeline.

As Alaskans do we really want to sacrifice the wilderness of the coastal plain for more oil when there are other less controversial areas available? Are we really so poor that we are willing to sacrifice what makes Alaska such a special place to live?

Yesterday we were asked why we aren't willing to compromise? The answer is we have already compromised.

Practically the entire coastal plain on the north slope of the Brooks Range is already available to oil exploration or is being opened up. The 1002 area in the Arctic Refuge is the only place on Alaska's north slope presently protected from development.

In other words 95 percent of Alaska's north slope will eventually be explored. Do we really want to develop this one place where we have the potential to protect the coastal plain from the mountains to the sea?

Some people say developing 2000 acres of the 1.2 million acre 1002 area will not affect the area. I can assure you that is not the case! No matter how far apart you spread the infrastructure the area will no longer be wilderness.

If developed, float trips across the coastal plain will be bisected by roads, pipelines, airports and other industrial development. The wilderness of the coastal plain will be no more. It will just be like Prudhoe Bay. People don't go to Prudhoe Bay to experience wilderness.

Thank you for your consideration on this issue.

I want to thank you for supporting Mr. Edgmon's resolution for the King Cove road.

I support building the road and the positions of the Aleutian East Borough and other supporters.

The road should be built properly and I believe it can be done without undue harm to the important wildfowl areas and eel grass beds.

I lived in Sand Point from 1978 to 80, Unalaska 80-85 and again Sand Point 85-89. I worked for ADFG in crab management and research so passed thru King Cove about 2 to 3 times a year, winter and summer. I spent quite a bit of time in Cold Bay too, hunting, driving the roads, working. I have experience tying up to the Cold Bay dock - when weather allowed. I've spent quite a few days anchored in Leonard Harbor when weather was too rough for work.

I sailed the waters from Kodiak to Sand Point, King Cove, False Pass and Unalaska nearly every year of living in the area.

I have flown in and out of King Cove and been weathered in and out of King Cove as well. It can be very scary. I've experienced last minute aborted landings into King Cove's airstrip. They deserve a road.

If the previously proposed land exchanges are needed to make the road possible, I support that as well - the refuge would gain substantial lands.

I had hoped to testify in support on January 27 but the change in order the resolutions were taken up caused me to miss the opportunity.

I would like you to add my comments here for the record and to pass on with the resolution as it makes its way to the floor.
