Dear Fisheries Committee Members,

As Program Manager of the Eyak Preservation Council, I am submitting this comment on behalf of myself and the organization I serve. The Eyak Preservation Council is a 501 c3 charity organization based in Cordova, Alaska, with a mission to honor Eyak heritage, and to conserve wild salmon habitat and culture through education, awareness, and the promotion of sustainable lifeways for all peoples.

Our Board of Directors (and all of our work) is Native-led. We recognize Alaska Native Peoples as the rightful, original stewards of these lands and waters we now call Alaska. The Eyak Preservation Council stands in solidarity with the United Tribes of Bristol Bay.

We oppose the appointment of Abe Williams to the Board of Fisheries. Williams, as a Pebble Limited Partnership employee, stands to benefit directly from proposed large-scale, open pit mining. If allowed, this mining would be at the expense of wild salmon themselves, as well as the people, cultures, and environments that rely on them in order to thrive. Large-scale, open pit copper and gold mines have a terrible track record of disaster and especially tailings dam failures.

If Abe Williams were appointed, it would be a blatant and disgraceful conflict of interest. Abe Williams should not be allowed to sit on the Board of Fisheries because of this major conflict of interest. Williams also cannot speak for the Native people of Bristol Bay, as he is neither Native, nor a full-time resident of Bristol Bay. As a general recommendation, the Board of Fisheries should strive for a great representation of Alaska Native Board Members.

We assert that every single one of the seven Board of Fisheries appointees should be people who are unbiased and stand for a strong future for wild salmon. Salmon are more than a resource. They are our relatives. Please do not allow Abe Williams to sit on the Board of Fisheries.

I came to Alaska in 1969 and immediately went to work for ADF&G aboard a scallop boat that was fishing out of Seward. I've worked as a deckhand on tenders and fishing boats for a number of years and owned my own fishing boat for three years. I have fished commercially for halibut, shrimp, Dungeness crab, and salmon (gillnet and troll), and for 18 years I operated Point Adolphus Seafoods, which specialized in sending live crabs and fresh fish to high-end markets mostly on the West Coast. I am the author of several books on Alaska's fisheries, including *Alaska Salmon Traps* and *Alaska Codfish Chronicle*. I'm presently writing a history of Alaska's herring fishery. I have attended a number of Board of Fisheries meetings and understand well the process.

Governor Dunleavy can do better than nominate Abe Williams to the Board of Fisheries. The one undeniable bright spot this summer in Alaska is the ongoing large run of sockeye salmon in Bristol Bay. There is no higher quality protein in the world. That our governor has nominated a paid advocate for the Pebble Mine is unconscionable. The House Fisheries Committee should reject Abe Williams. For anyone concerned about the future of Bristol Bay, rejecting him is a no-brainer.

I know nothing of McKenzie Mitchell, but the fact that she was nominated by the same person who nominated Abe Williams is a big strike against her. Moreover, fisheries are very much a coastal issue, and Mitchell is from Fairbanks. John Jensen shouldn't be the only board member who lives on the coast. Unless Mitchell can be extremely convincing that she will do the right thing by our fish, she, too, should be rejected. Instead, the governor should nominate someone knowledgeable about our fisheries and with a track record of dealing with complex and often controversial issues with knowledge and integrity.

I am writing to express my significant concerns about Mr. Abe Williams' nomination to the Board of Fisheries by Governor Dunleavy, and to encourage the Legislature to reject his nomination.

The role of the Board of Fish is conserving and developing Alaska's fisheries and confirmation of Mr. Williams would call into question the Board's ability to responsibly manage Bristol Bay fisheries.

Mr. Williams has spent much of his career working to promote the proposed Pebble mine, which risks severe impacts to the sustainability and profitability of one of our state's most important fisheries. In recent years he has filed a lawsuit funded by the Pebble Limited Partnership against fellow commercial fishermen, consistently mischaracterized the overwhelming views of commercial fishermen and local communities from the region on the proposed mine, and testified dozens of times in support of developing the project despite the fact that it would permanently destroy between 105-300 miles of rivers and streams in the region. His long-standing commitment to the proposed Pebble mine and willingness to cast aside the undeniable harm it would cause to the local fisheries raise grave concerns and unresolvable conflicts with his ability to fulfill the responsibilities of the Board to conserve and develop Alaska's fisheries.

Bristol Bay has maintained near constant representation on the Board of Fish for 40 years. Replacing a board member in good standing who represents both the State's largest salmon fishery and rural Alaska with an active advocate for the Pebble Mine flies in the face of the values and priorities the Board of Fish is mandated to represent.

I urge the legislature to reject the nomination and encourage the Governor to find a more suitable candidate that has the faith of fishermen in fulfilling the Board's important role in managing our fisheries. We need our governing bodies to represent Alaskans and the real issues impacting our future, not the special interest of outsiders trying to devastate our pristine resources.

One question I often ask myself, is what kind of Alaska will we be leaving for our children and their children to experience? Will wild salmon and clean water be a mere mention in their history books? Or will those history books talk about how major jewelry companies such as Tiffany & Co. even boycotted the use of unethically, unsustainably, harvested gold from the Pebble Mine? To All:

My name is Jack Donachy. My wife Barbra and I are full-time residents of Chignik Lake, Alaska.

Via phone, I listened with great interest - and concern - to public confirmation hearings regarding Governor Dunleavy's appointments to the Alaska Board of Fisheries on September 3. As part of those hearings, I provided oral testimony in strong opposition to the confirmation of Abe Williams.

I am submitting this letter in addition to that testimony.

I found it troubling that representatives did so little to push back on Mr. Williams' testimony. To wit:

- As per the Alaska Board of Fisheries home page on the Alaska Department of Fish and Game website, and per Alaska Statutes 16.05.251 paragraphs (1) and (7), it is clearly stated that **conservation** of fisheries resource is a primary mission of the board. This mission includes the Board's capacity to identify sanctuary areas. Yet I heard no clear question from representatives directing Mr. Williams to address this critical board mission and the glaring conflict of interest his pro-Pebble advocacy indicates.
- When asked whether or not he owned stock in the Pebble Mine Project - a Yes or No question -, Mr. Williams was evasive. He stated that stock options were available through his employment with Pebble, but that he had not taken advantage of those options. The questioner seemed to recognize that Mr. William's answer was evasive, and she repeated it. Again, Mr. Williams declined to offer a simple Yes or No response. Thus, the possibility that Mr. Williams does in fact own stock in Pebble, *or that he stands to receive other inducements for pushing the Pebble project forward*, were ignored by hearing members.
- One hearing member used his time primarily to testify on behalf of Mr. Williams rather than ask questions. During his favorable testimony, this member made an unsupported comparison between unnamed mines and fisheries in Southeast Alaska and the proposed Pebble mine in the Bristol Bay region.
 - Am I to understand that it is the job of members, in a public hearing, to offer beneficial testimony for candidates they "like" rather than ask relevant questions?
 - Allow me to give this member the same opportunity I have offered Pebble members and their supporters for the past several years: *Identify, anywhere in the world, a mine similar to the one the Pebble Partnership is proposing, sited on a watershed, that has not significantly damaged*

that watershed. The public hearing of September 3 was an opportune time for this member to divulge such information rather than to offer an unsubstantiated, vague pro-Pebble comparison.

- Mr. Williams' was permitted to cast himself as a "good communicator." Yet Mr. Williams referred to those who oppose his views as "loud voices," dismissed their sentiments as "robo-texts," and complained that "most of them" were from out of state. Despite the obvious contradiction between Mr. Williams' description of his communication skills on the one hand and his dismissive attitude toward those who disagree with him on the other hand, committee members offered little push-back.
 - Citizens sometimes become "loud" when they feel they aren't being listened to. More likely, they feel they must repeat themselves and in Mr. Williams mind, this repetition seems "loud." Mr. Williams is choosing to ignore multiple polls - and the voices of the majority of residents of Southwest Alaska *whom he claims to represent* - in dismissing their concerns about the proposed Pebble project.
 - I doubt that Mr. Williams has received *any* robo-texts on this or related matters. What he is more likely seeing are form letters and emails - correspondence individually signed by people who care about these issues. These letters are sponsored by legitimate advocacy groups such as Trout Unlimited and other organizations whose members value the Bristol Bay fishery.
 - According to the meeting minutes of September 3, 24 out of 100 letters came from out of state. While 76% of the correspondence came from Alaskans - indicating strong in-state opposition - it is neither surprising nor insidious that people from the Lower 48 such as commercial fishing permit holders from Washington and sport anglers, hunters, photographers and nature lovers from all states would write to express opposition to a supporter of Pebble Mine being appointed to the Board of Fisheries.

The committee grilled one appointee extensively about her commitment to subsistence fisheries. That questioning was appropriate - and frankly left some of us unsatisfied as to her appreciation and understanding of this issue. All four candidates were flawed. But a person who is right for the board can read, engage in research, talk to stakeholders and quickly get up to speed.

If they have the right attitude. If they are willing to listen, read, see and learn.

Mr. Williams appears to lack the conservation-minded attitude that is specified in the Board of Fisheries mandate. And he clearly lacks the listening/reading/seeing skills necessary to productive communication. He should have been questioned with more rigor. And, again, really... is it the job of board members to advocate for candidates they "like," or to let them slip away with evasive answers, rather than ask them well-crafted questions of probative value?

The hearing provided illustration into why many residents of coastal Southwest

fishing and subsistence communities do not trust the Board and do not trust processes as they relate to the Board.

We urge members to reflect and to do better.

Hello Committee Chairs and Members,

I request that you reject Mr. Abe Williams appointment to the Board of Fish.

I am a resident of Petersburg. My family has drift-netted in Bristol Bay since 1991, including myself, my husband, my three sons and their respective families for a directly affected total of 8 individual family members. This does not include our crews who also have dependent families. We are heavily invested in the Bay, with three different operations and a large chunk of our annual incomes are derived from the fishery there.

Understandably, we become concerned when we perceive a direct threat to our livelihoods such as the proposed Pebble mine poses. For this reason, I ask that you do not appoint Abe Williams to the Board due to his conflict of interest with the Pebble Partnership. To do so would introduce a level of bias that quite simply would destroy the public's confidence in the Board of Fish process. Moreover, a Board of Fish action on the proposed mine could potentially have a much greater impact on the lives of Bristol Bay fishermen than any allocation issue, rule change, or quota recommendation that may come before the Board.


Mr. Williams has been employed by the Pebble Partnership for 10 years and has been their Director of Regional Affairs for two years while collecting a quite lucrative salary of between \$100 -\$200 thousand, during only a four month period. Any assumption that such a salary would not influence his decision-making is pure fantasy. His ties to Pebble represent a direct conflict of interest and should immediately disqualify him from consideration because of the huge controversy that the proposed Pebble mine continues to pose.

Mr. Williams duties with Pebble, seemingly as a as a de-facto lobbyist for the Pebble Partnership's agenda, would introduce conflict right out of the starting block. The Board has much hard work to do, especially during a time of struggling/declining Alaska fisheries. Devoting time to quelling controversy revolving around his conflicts of interest would mean diverting already scare time away from working on those vitally important issues. Even if Mr. Williams recuses himself, please consider that the Board should be operating with a full deck, and not automatically resigning itself to less than full participation by board members on any issue.

Certainly there are much more qualified and non-conflicted individuals who could represent the fishing community instead of the immediate conflict upon appointment, introduced by Mr. Williams association with the Pebble Partnership. The Board of Fish needs members who can vote on as many issues as possible without automatically being conflicted out.

Please reject Mr. Williams appointment to the Board of Fish.

Good morning,

My name is Evelyn Corbett and I am a resident of Dillingham, Alaska.

I oppose the appointing of Abe Williams because it tilts the tables of bias on the Board of Fish. We know that Abe Williams is a supporter of Pebble Mine, but we also know that Alaskans are overwhelmingly against it.

The only "valid" reason for Pebble Mine is economic infrastructure. However, this reason is not valid enough. No amount of economic infrastructure is worth risking our salmon, our clean waters, our food sovereignty, and our livelihoods.

So this is my question: What is Abe Williams?
Is he a fourth-generation fisherman of Bristol Bay or the Director of Regional Affairs for the Pebble Partnership?

These two parts of identity conflict each other almost entirely. I won't take the chance that Pebble Mine is "safe." There are too many instances where the government deemed things such as mining safe and they devastated the land and waters and nothing was done about it.




To the House Fisheries Committee,

I was unable to finish my testimony during the confirmation hearing and I would like to submit my full statement here. The last paragraph, in bold, is what I had to omit from my oral testimony and also a point that I have not heard be made yet:

Good afternoon, my name is Mariel Terry, I am calling on behalf of myself as a concerned citizen. I am, in fact, not a robot but a flesh and blood Alaskan born and raised. My residency is in Anchorage but I split my time between Anchorage and Bristol Bay where I work as a fisheries scientist. I am calling to voice my opposition to the appointment of Abe Williams to the Board of Fish. I am greatly concerned by the prospect of someone who is receiving payment and employment by out-of-state and international corporate interests that are misaligned with the majority view of the region to which he would be tasked to represent. The Board of Fish was established for the purposes of conserving and developing fisheries resources around Alaska. The entity that Williams is employed by, the Pebble Partnership, is attempting to permit a development project that the Army Corps of Engineers recently admitted would likely result in significant adverse effects on the aquatic system, that is to say a project in direct conflict with the mission to conserve and develop the fisheries resources of the region.

There is a grand and lengthy body of evidence to suggest that Abe Williams has a very clear and targeted agenda. I watched an interview recently, one of many that I have seen and read while doing research on Mr. Williams, that was dated seven years ago, in 2013, where Williams vehemently advocates for the development of the pebble mine under the pretext that it would bring economic growth to communities in Bristol Bay. At the time he sounded like a great candidate to hold a paid position with the Pebble Partnership which he now coincidentally does as the Director of Regional Affairs. Considering what is now public information about how the Pebble Partnership goes about furthering its agenda, for example a promised multi million dollar payout to its CEO if the mine were to successfully become permitted, it could be inferred that Williams is now being paid a significant salary to systemically advocate on behalf of the mine. It is greatly concerning to me that an individual in such an overtly political position would be tasked with objectively synthesizing and incorporating scientific assessments provided by scientists with the Alaska Department of Fish and Game. It is also greatly concerning to me that a person tasked with ensuring the success of a large scale mine that according to the Army Corps of Engineers would have would likely result in significant adverse effects on the aquatic system or human environment would be selected to represent a community that a recent poll found opposes the mine by 77% ([commissioned by United Tribes of Bristol Bay](#) and conducted by Hays Research Group).

According to an article published by Alaska Public Media this morning, Williams has previously stated during his senate confirmation hearing that he would recuse himself from voting on matters pertaining to Bristol Bay. So essentially, if Williams were to be appointed and he were to adhere to this protocol, the Board of Fish would then only have 6 voting members when it came to matters affecting this immensely important fishery. As a resident, I would much prefer to have seven fully functioning member on the board. I urge the House committee to reject the appointment of Abe Williams to the board in favor of someone without the conflicts of interest that he brings to the table and better suited to carry out the mission of the Board of Fish. I echo the sentiment of others who have testified that I would like to see increased representation from rural, coastal, fishing communities. Thank you so much for the opportunity to testify.

Thank you. Members of the House Fisheries committee.

My name is Paula Cullenberg and I live in Homer, Alaska. My family have been permit holders in the Bristol Bay setnet fishery for 38 years and in addition we operate a small direct marketing business.

I am calling to express my opposition to the appointment of Mr. Abe Williams to the Board of Fisheries. I am opposed to this appointment for two reasons.

First, the Board of Fisheries is a trusted, credible and open process that impacts fishermen across Alaska. Currently the Pebble Partnership, who employs Mr. Williams, is requesting a permit from the state to build a mine at the headwaters of some of Bristol Bay's valuable salmon habitat. As we all know, this is a very controversial and charged issue in our state. Placing an employee of Pebble Partnership on the Board of Fisheries will impact the Board's credibility and trust among stakeholders, reducing the effectiveness of the Board. This makes Mr. Williams a poor candidate at this time.

I also believe that the state would be better served if this seat was filled with a rural coastal resident. Currently there is only one coastal rural resident on the Board. Given that the subsistence and commercial fisheries of our state make up the core economic input to our coastal communities, it is critical that the Board include rural coastal residents who have this perspective and experience to contribute to the Board's decisions. There is a decades long history of a Bristol Bay watershed resident involved in commercial or subsistence fishing serving on the Board of Fisheries. There are many individuals living in the region who would do a good job on the Board of Fisheries and bring this understanding and experience to the process. The Governor should appoint someone who lives in rural coastal Alaska.

For these two reasons, I believe that this nomination hurts, rather than helps our state's Board of Fisheries process. I encourage you to vote against confirmation of Mr. Williams for the Board.
