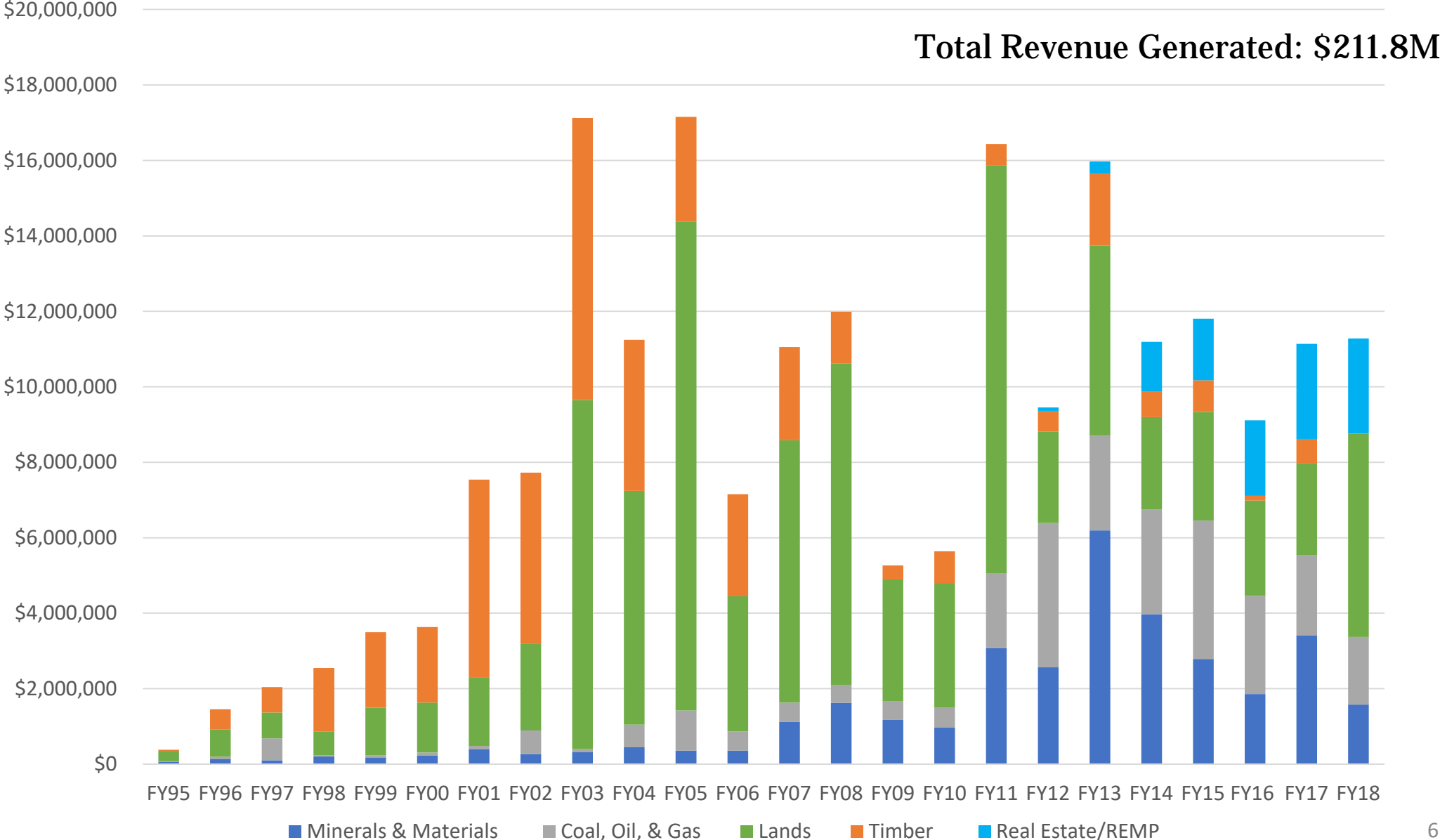

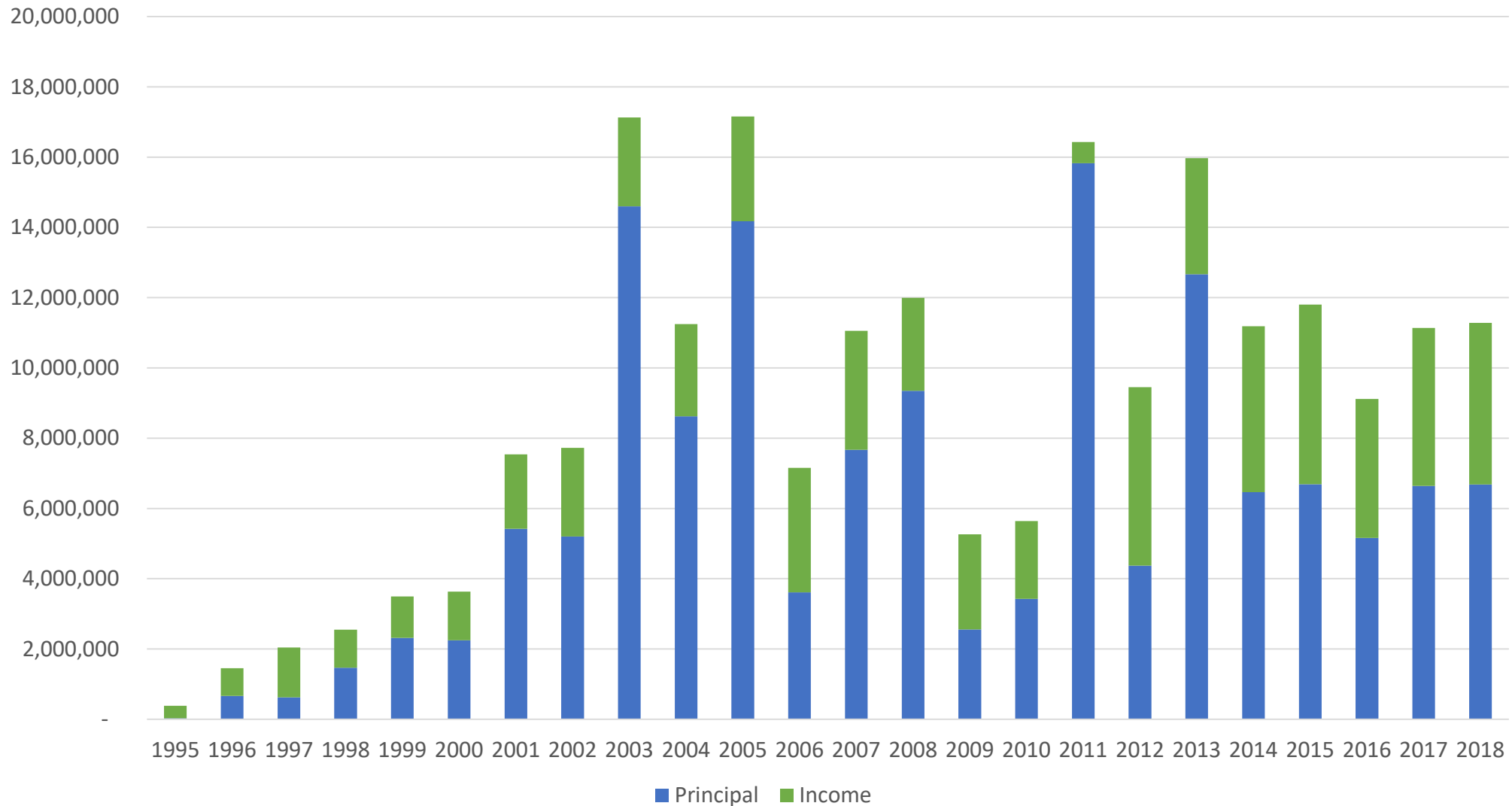

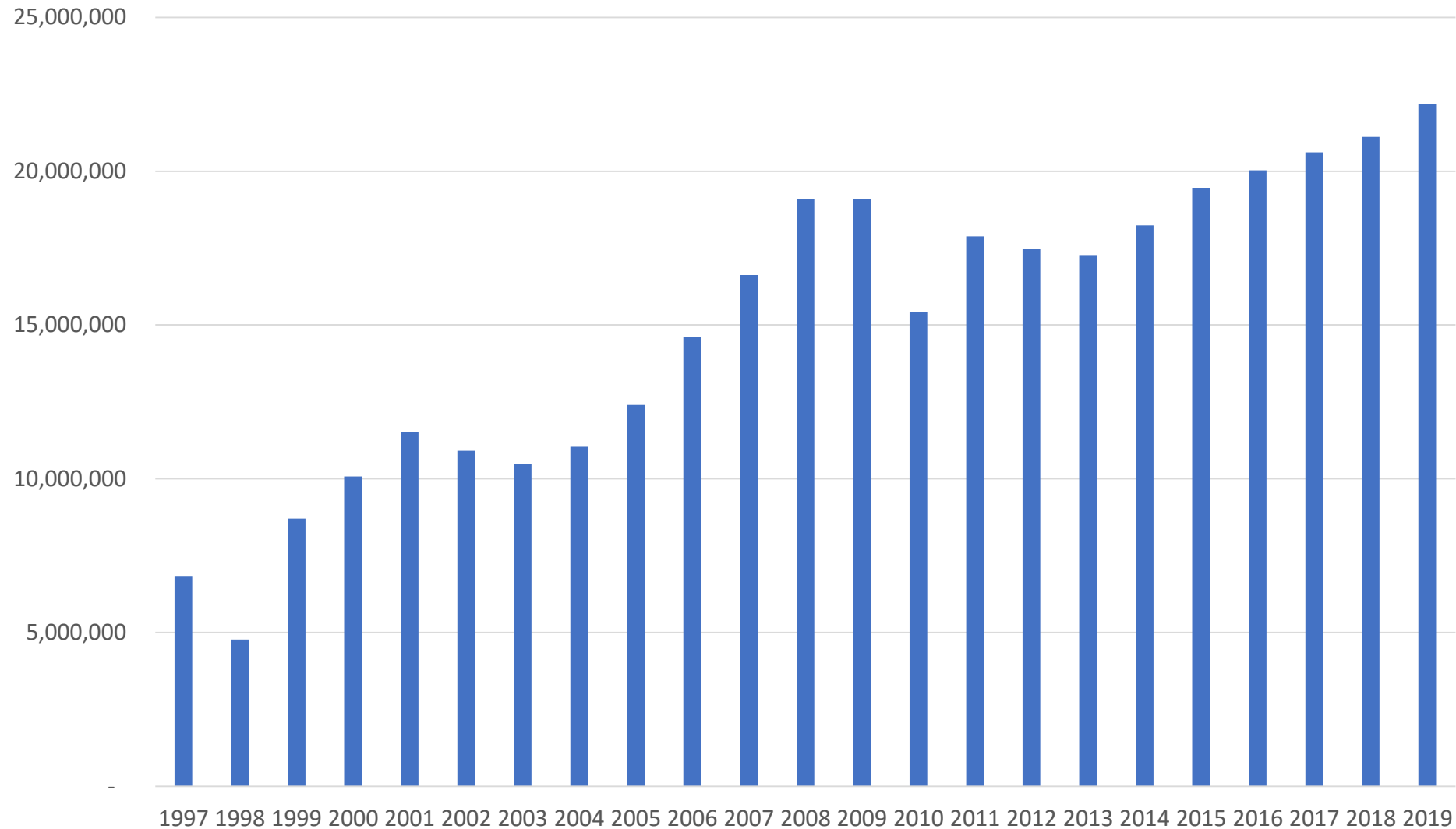
# Trust Land Office Annual Revenue

# FY 20 Trust Grant Allocations

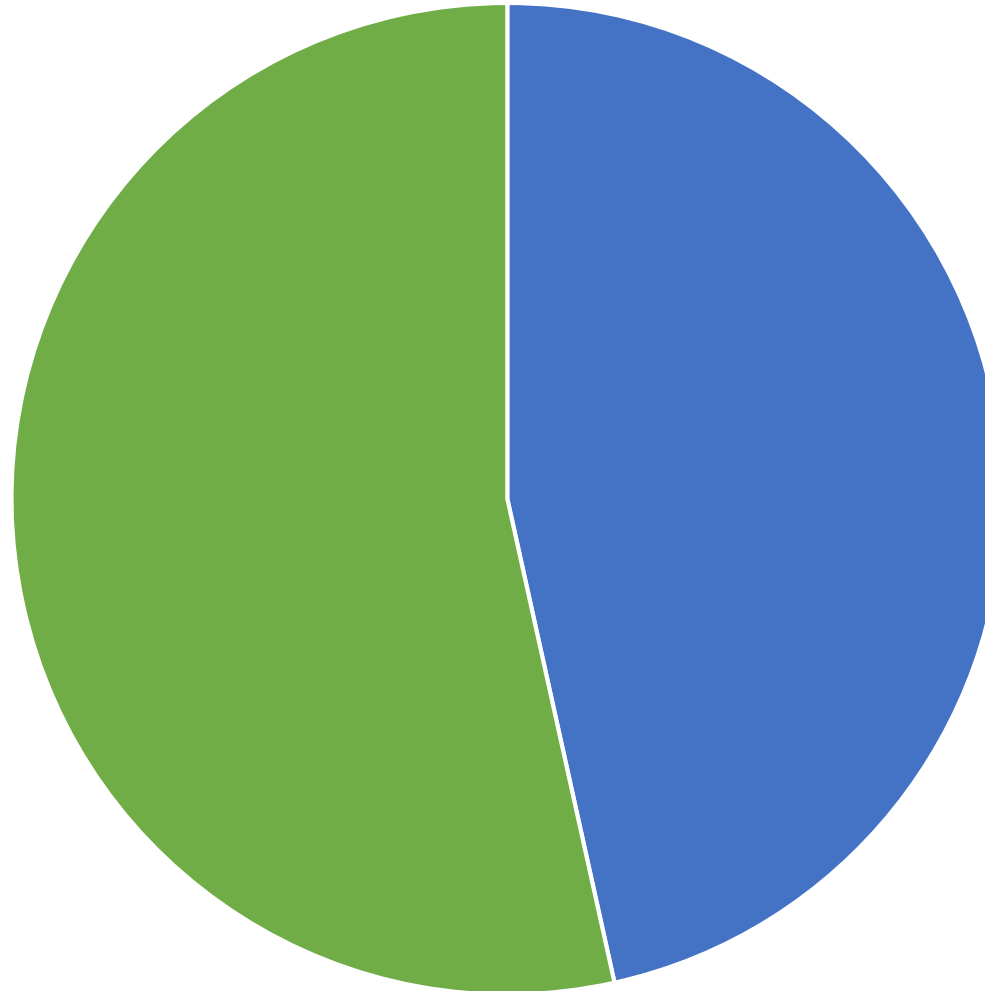

## Authority Grants

\$12,336.7

# Mental Health Budget Bill

- Trustees approved \$10.7M in Mental Health Trust Authority Authorized Receipts (MHTAAR) to SOA departments for beneficiary related programs and projects
- Trustees also made recommendations of \$5.5M in GF/MH funds to the Governor and Legislature
