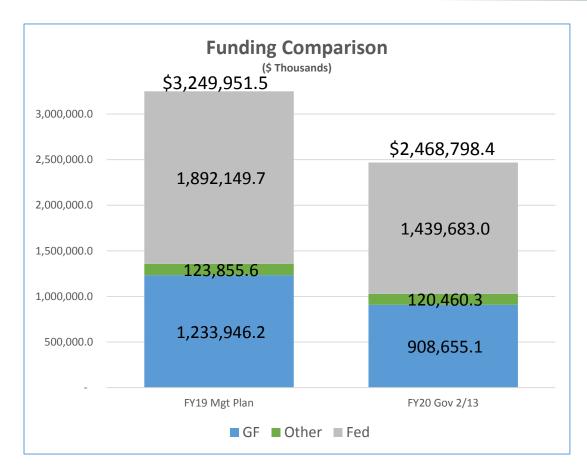

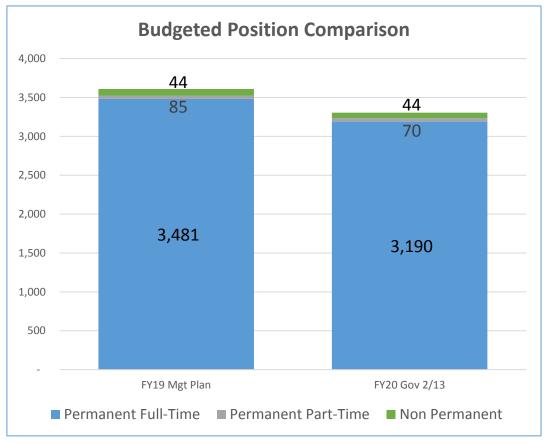

Department of Health and Social Services: Funding and PCN Comparison

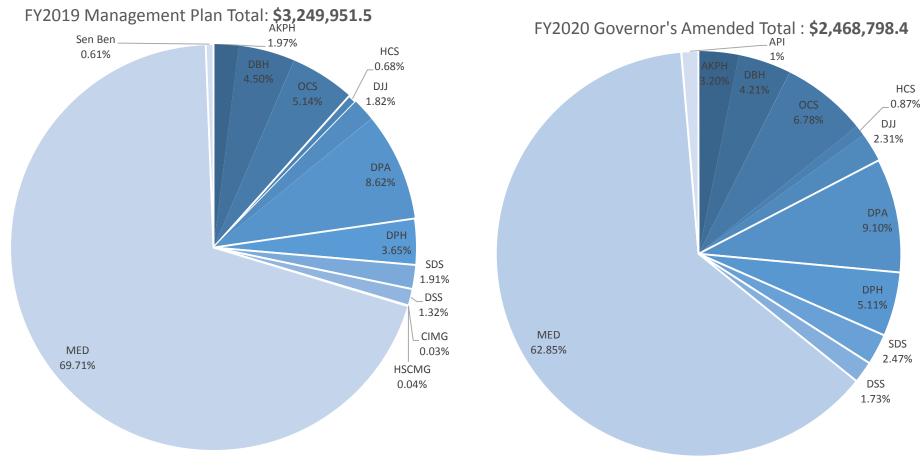






Department of Health and Social Services Operating Budget: Fiscal Year Comparison

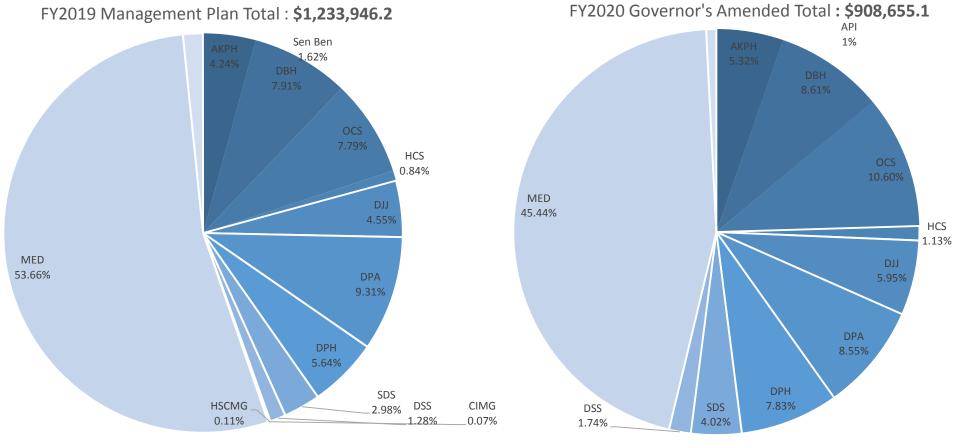
