FISCAL NOTE ANALYSIS

STATE OF ALASKA 2019 LEGISLATIVE SESSION

Analysis

Provisions of the bill apply to juvenile offenders under the jurisdiction of the Division of Juvenile Justice. Sections 19 and 20 clarify that juveniles under the jurisdiction of the Department of Health and Social Services, Division of Juvenile Justice can be charged with the crime of escape related to tamering with, disabling, or removal of electronic monitoring equipment.	
The division handles juvenile offenders based upon their individual needs and risk to reoffend. None of the proposed changes will not have a fiscal or major programmatic impact on the Department of Health and Social Services, Division of Juvenile Justice.
