







Mission Statement




Judiciary Appropriations (GF Only) (\$ Thousands)




Judiciary Appropriations

(All Funds) (\$ Thousands)








^{*} Changes in the personal services line from FY10 to FY20 are segregated into two parts: {1) base increases {primarily due to contractual negotiations, retirement increases, and health insurance increases), and {2) other personal services increases/decreases such as transfers between line items or new/deleted positions. The final column sums the two types of changes during the period.

^{*} The FY16 cut was offset by a 2.5% salary increase resulting in a net reduction of \$1,427,600.


^{**} The FY18 cut was offset by increased healthcare costs resulting in a net reduction of \$1,821,400.





Alaskans Served in 2018


- 123,247 new cases filed (trial and appellate)


- ➤ Between FY16 and FY19, Deleted 44 PFT, 14 PPT, and 2 Temporary Positions for a total of 60 Deleted Positions



FY20 Governor's Amended Request


- > \$ 393,800 Facility Expenses

 \$3,491,800 Total FY20 Increments





Policy Change – Full Day Fridays

- Court system will resume a 37.5 hour workweek and remain open for full days on Fridays
- More time for calendaring proceedings and less delay in handling court proceedings
- Alaskans will have access to courts on Friday afternoons to conduct business




