My name is Lisa Coates and I reside in the city of Kenai. I am contacting you to voice my concerns over the recent removal of an industry representative on the Marijuana Control Board. Gov. Dunleavy has removed Brandon Emmett from the board and wishes to replace him with Vivian Stiver, who is a strong opponent of the cannabis industry. Based on her previous actions against the cannabis industry, one can only conclude that it will be her intention to shut the industry down, not regulate it. She does not represent the will of the general public which voted overwhelmingly in support of a regulated cannabis industry.

This industry has slowly blossomed since its legalization in 2014, which passed by historical margins. During a state recession, this industry has created more jobs in the last few years than any other startup industry in the state. The industry creates jobs, not loses them. If Stiver is confirmed, it will most assuredly be a step back towards prohibition days, while the rest of the world and country are slowly progressing towards legalization. It is the will of the majority to regulate it, not stomp it out.

I live and own a business in the Mat-Su Valley and I am opposed to the appointment of a prohibitionist like Vivian Stiver to the Marijuana Control Board. Through the course of multiple campaigns that attempted to prohibit businesses across the state, we have seen that the public vote in favor of regulation vs prohibition. Each vote showing a high favor rating with higher voting turnouts in decades. I believe that the Industry/Public seat should reflect the more than 2 thirds of Alaskan's that voted for legal cannabis.

I have lived in the Mat-Su Valley for 9 years and owned a home here for 8 years of that. I am the owner and CEO of Green Jar, the first retail store to receive a Conditional Use Permit and to open in the Mat-Su Valley. We have three owners and 23 employees that are all counting on the jobs we have created. The Mat-Su Borough received \$741,013.28 for all of 2018 and \$1,034,560.48 total since inception.

We have an already robust regulatory system that governs the sale of cannabis in our state. I know because I have attended every meeting that was publicly held by the MCB and hold a license. I demand as a licensee that those regulations stay strong for all parties involved since following the regulations gives my business legitimacy. Those regulations could be turned to damage the ability of 26 people to continue to make a living in the Mat-Su Valley.

I DO NOT believe Vivian's prohibitionist past gives her credit to say that she represents either the "Public" or "Industry" which is the seat she is to represent. Dear Governor Dunleavy,

The purpose of this letter is to provide my perspective on the potential board replacement of Brandon Emmitt with Vivian Suver.

I am a life-long Alaskan who has owns a commercial fishing operation and previously owned a commercial design-build general contracting business. My wife is an Occupational Therapist who worked for many years in the Anchorage School District and I am a licensed engineer in the state. We have three children ages 18 to 21 who have been through the public school system in Anchorage.

In 2016 we decided to invest in the Marijuana industry, something we knew little about at the time. Two years, much capital, a huge learning curve and much hard work later we have a successful business employing 33 people full time in Isidore LLC (cultivation), AK Rime (manufacturing) and AK Frost (retail). We paid in excess of \$1.3 million in cultivation taxes in 2018 and collect approximately \$25,000/month in Anchorage municipal sales tax.

In my opinion, the reduction of industry representation on the board to one member further degrades the already limited knowledge of the Board regarding the industry. I acknowledge that industry opponents can act fairly and appropriately as board members. Former board chair Peter Mylarnik was an opponent of the industry who provided a balanced perspective. He acted and voted fairly and objectively while acknowledging that the board is tasked with regulating the framework of an industry supported by the majority of the state. He also was active on the board as a public safety seat and did not displace one of the two available industry seats. Industry seats are very important to the board to provide information and knowledge regarding an industry that is very new and constantly evolving. The inclusion of Brandon and Nicholas on the board has provided the bare minimum of knowledge and experience about how the industry actually functions. To handicap the board by reducing the actual knowledge base of the industry will only lead to slower performance by the board and misinformed decisions.

Most boards are staffed by people with a variety of (often competing) interests in the industry or resource they are regulating. It is understandable to have public safety, rural interests and public health interests represented on the board. It appears that Ms. Suver's principal interest in the industry is opposition. This feels inappropriate to me.

I believe I have a unique perspective of the industry having no experience prior to legalization. As a previous non-user who has come to understand and enjoy the product in a responsible way, I have come to appreciate providing the wide demographic range of our customer base with marijuana in a safe, legal and less-stigmatized environment. I have come to realize that there is absolutely no reason to persecute the use and distribution of marijuana beyond what seems the status quo for alcohol.

Thank you for your time and consideration of this matter. If I can be of any assistance in providing a close view of the industry and the process, I would be happy to provide you or any of your staff a tour of our facility of which we are quite proud.

Dear Representative LeDoux,

I've not been in Alaska long, just since July 2018, but my husband has been here since 2008. He is the head cultivator of a new limited cultivation license and has their first harvest happening in a couple weeks.

I am writing to share my concern for the appointment of Vivian Stivers to the Marijuana Control Board. The appointment of a known prohibitionist to a governing body that already has known "no votes" in this industry is frightening. The statements made by Ms. Stivers are also frightening. She speaks of fairness and ramifications in the industry; of educating those of us involved in how the industry and regulations of the cannabis industry work. She has made comments about looking into past decisions of the board and "what needs to be done" (all of these comments as per her interview with the Daily News Miner).

I can tell you right now that every person I have met in this amazing state who is involved in this industry is in it for the right reasons. They KNOW the regulations and laws like the back of their hands and when in doubt, they call the Alcohol and Marijuana Control Board for guidance. This is our livelihood, the way we will feed our family and the way we will pay for our children's healthcare and happiness. This industry is not lucrative; no one expects to be a millionaire. We simply want to grow plants that provide relief and better quality of life for those who need it. We want to do that legally; taking care to follow to the letter every law, regulation, and suggestion of the government.

Not only do we want to provide for our families and the well being of other folks, but we want to give back to the great state of Alaska. We want to improve education by donating money and supplies to schools. We want to decrease homelessness and hunger by donating money and supplies to shelters and food banks (and maybe even education - who knows how to grow a garden effectively and at a low cost better than those who grow plants for a living?). We want to create jobs, in an industry that is growing and hiring on help (not to mention the money given to the government of Alaska through the selling of handlers cards and taxes through paychecks). We want to stop underage smoking by keeping our doors tightly sealed to those under the legal age of 21. We want to stop the black market sales of harmful products that are grown and made with no regulation or testing, in dirty environments, with no standard of safety or public health.

You have to understand that this agricultural product is heavily regulated. We do not make a move without AMCO or the MCB knowing about it. There's no sneaking around, we aren't peddling our wares to children, we aren't those creeps on the corner looking all sketchy and lowering property values. We are solid Alaskans, taking pride in an industry that can help people, an industry that is purely Alaskan, an industry that is a model for the rest of the United States of America.

I am asking you to not confirm Governor Dunleavy's appointment of Vivian Stivers to the Marijuana Control Board. I am afraid she will undo all the good that the board has done so far. In my opinion, they have been very fair and scrupulous in their examinations of licenses and proposals. They take a lot of time to review every word on our license applications (We fixed ours several times to meet their standards, which we appreciated - no one wants to get the go ahead only to be shut down). They research thoroughly every proposal that is brought their way. They hand out appropriate and just punishments to those (very, very, very few) who choose to ignore the rules.

If this was alcohol, would there be such an uproar? The black market sales have gone down; I've overheard kids in high school speaking about how they "can't get any weed." With cheaper, higher quality products legally available to consumers of the appropriate age, kids cannot get their hands on it. Why does it seem like this appointment is the first step in shutting down the legal sale of cannabis, turning all legal cultivators, manufacturers, and retailers into criminals? Our industry has been so good for the state of Alaska, and it feels like this appointment is the first step to turn that around; to set us all up for abysmal failure? Not just those of us with licenses, but our employees, the people who can't grow their own (but need it for their aches and pains, for their depression and anxiety, for their seizures or Parkinson's or migraines), and our government (remember, we pay \$800 a pound to the Alaska State government plus taxes pulled from paychecks, gas money to legally transport our goods to legal retailers, electrical bills, water bills, gas bills to grow our plants, license fees, and operating taxes).

I also have to mention that, while a known prohibitionist can offer a valuable viewpoint, we already have that on the MCB. They already have skeptics who question everything. Honestly, that's a good thing! But we NEED an industry member on the board; someone who understands because they live our lives. Someone whose family relies on this industry staying legal and fair. It's here I will point out that I do not oppose the appointment of Trooper Jaime. I think the board needs someone who has extensive knowledge and experience of the industry from the illegal side, someone who is deeply connected to public safety. I felt like Ankerfelt was doing a fine, upstanding job in that role, and that his dismissal was retaliation for his "yes" vote for the on site consumption proposal (which was always a goal of the 60% of Alaska s who voted in favor of legal marijuana use). However, I think he was replaced with a good candidate. I am primarily concerned with Ms Stivers' history within the legal cannabis industry. As recently as May 2018, she was openly opposing cannabis consumption and legality in Fairbanks. Her "Safe Neighborhood" group is a great idea, but aimed in the wrong direction! Legal cannabis users are safe! They are using a highly regulated, tested product, in their home, not walking around the streets convincing kids to imbibe! Why, in my experience, there is a much bigger problem of that nature in the Alcohol industry.

Please, please do not confirm Vivian Stivers! I do not want my family's livelihood to be done away with. I want my husband home for dinner every night, not up on the slope for weeks at a time, doing a job that crushes his soul. I don't want our future children to barely know their daddy because he is off providing for us (a substitute teacher/work from home/waitress -yes I have 3 jobs- salary cannot support us).
