## FISCAL NOTE ANALYSIS

### Analysis

This bill amends AS 44.41 by adding a new section to require law enforcement agencies to submit to the state crime lab for testing, all sexual assault examination kits collected by the agency within six months after collection.

Per department policy, the Alaska State Troopers (AST) must submit sexual assault kits to the crime lab within 30 days of collection. Passage of this bill would have no fiscal impact to AST. Therefore, a zero fiscal note is being submitted.
