This reduction will necessitate an increase to the general fund amount to offset the PSTF decrease, and will be required to fully support distributions to school districts through the foundation formula with a Base Student Allocation of \$5,930.

These funds will be directed towards implementation of the recommendations of the official report of the Alaska Task Force on Reading Proficiency and Dyslexia, which is expected on March 29, 2019.

Recent developments in the understanding of the science of reading offer a path forward in addressing chronically low student reading scores in Alaska. Areas of focus will include evidence-based reading instruction, early screening and intervention, improved data, improved student readiness, professional development for teachers, preservice education, broadband access for rural schools, dyslexia awareness, dyslexia intervention, and implementation and accountability measures.

EXPLANATION: These funds will go to Parents as Teachers.

As their child's first and most important teacher, parents play a crucial role in supporting school readiness. Parents As Teachers is an evidence-based home visiting model that supports learning and health of children by supporting and engaging parents.

There is currently a substantial waitlist of families requesting Parents As Teachers services. This funding helps to meet that demand and offers communities now waiting in line to offer this service. The number of families served is estimated to more than double, leveraging the infrastructure and trained teaching staff already in place.

Investing early in a child's life optimizes the return on the state's investment. Research shows that children who participate in Parents As Teachers are better prepared for kindergarten and experience lower rates of abuse and neglect. Parents stay engaged with their children's learning into the K-12 years. Additionally, at a pivotal time in a child's development, children are screened for health and developmental delays, leading to successful interventions and better outcomes.

This is a strategic investment in the long-term health and success of children, utilizing a proven, research-based approach that leads to better school and life outcomes.

RECOMMENDED WORDAGE

It is the intent of the legislature that the Department of Education and Early Development shall work with [REDACTED] Head Start providers to create an equitable and geographically weighted formula for disbursement of state funded grants to allow for the most students served with a comprehensive early childhood education by January 21, 2020. The Department will keep the Legislature informed of allocation decisions and funding formula results.

EXPLANATION: This wordage directs that the Department develop a funding formula for Head Start [REDACTED] so that funding is equitably distributed and that the Department will keep the Legislature informed of allocation decisions and funding formula results.

RECOMMENDED LANGUAGE:

It is the intent of the Department of Education and Early Development Finance Subcommittee to recommend for consideration of the full House Finance Committee the removal of funding for the State Board of Education and Early Development (SBOE) approved 3-year pilot curriculum program, which totals \$19.5 million in Gen Fund (1004) and the corresponding three positions, which total \$457,600.00 in Gen Fund (1004). It is the intent of the subcommittee to recommend to the legislature to repeal the education requirements in Chapter 73, SLA 2018.

EXPLANATION: Because it is the intent of the Subcommittee to recommend to the full House Finance Committee the removal of funding for the Education Curriculum Requirements and to the legislature to remove the requirements in statute, the committee deletes the positions for the program.
