I have lived in Alaska since 1975 first in the interior and now in Sitka. I love and cherish this state. We have so much; we have such rich culture and such an opportunity to continue to support ourselves with world class renewable resources, commercial fishing and tourism. We should not appoint a commissioner of DEC who is obviously pro Pebble mine, and has a documented history of supporting the Pebble Partnership and the large scale commercial mining industry. This enormous mine is of such a scale and in such a sensitive, significant wild salmon habitat that this project will jeopardize our commercial sport and subsistence fishing in Bristol bay. This is not just an Alaskan problem: we have tourists from around the world; we sell our wild Sockeye salmon around the globe and if we poison our salmon, other animals as well as humans, will eat the fish and carry the heavy metal contamination around the world. The economic and environmental costs of permitting this mine are just too high a risk. More importantly appointing a commissioner who is not neutral on this issue and would almost certainly give Pebble mine a green light. Although I would like to see an environmentalist appointed commissioner, I realize that it is more reasonable to expect a neutral person. Jason Brunc is a champion of large scale mining; he is not neutral, and he should not be appointed commissioner of the department of ENVIRONMENTAL conservation.

I am a retired Fisheries Biologist with ADF&G with years of experience with water quality and resource management. I have extreme concern of Mr. Jason Brune becoming DEC commissioner. The basis of my concern is Mr. Brune's strong support of the current Pebble Mine Project proposal. His support of this project is a clear example of his lack of experience and judgement. The Pebble Mine Project, as proposed and supported by Mr. Brune, is a disaster waiting to happen. There are so many aspects that could fail and endanger valuable fish habitat, wildlife habitat, and water quality throughout the entire watershed. The people associated with this project are outsiders and have nothing to lose if the dam fails or a culvert collapses or a myriad of other things could go wrong. In my 27 years of fish and wildlife work with ADF&G, there has never been a project proposed that would potentially impact valuable fish and wildlife resources more than this one. Based upon the project proposal and all the other versions going back 15-20 years, nobody has been able to come up with a proposal that would deal with all the potential sources of on-the-ground or instream failures. The man you are considering for DEC commissioner is not impartial, based on the fact that prior to his nomination for DEC Commissioner, he was in support of the project. He has insufficient educational experience or professional experience that could ensure the public that Alaska's water quality, fish habitat, and wildlife habitat would be considered and protected in our state. By placing this gentleman in charge of DEC without any significant demonstrated prior water quality management experience, you will be placing at risk those values that will affect thousands of people downstream in Bristol Bay, as well as statewide. Jason Brune should not be appointed to be the Commissioner of the Alaska Department of Environmental Conservation. The DEC is the primary state agency responsible for protecting Alaska's air & water quality. DEC is the entity that would issue the state permits necessary to develop Pebble Mine.

It is difficult to imagine a more controversial candidate than Jason Brune to head an organization responsible for protecting Alaska's environment. Jason Brune has spent the last two decades advocating for mining projects in Alaska. **He was literally the spokesman for the Pebble Mine.** DEC is the entity that issues the state permits necessary to develop Pebble Mine. He has absolutely no record of ever favoring environmental protection over resource development. There would be no public faith in the decision process for any resource development project issued permits.

Dear House Resources Committee,

I live in Juneau and am a lifelong Alaskan. I am writing to oppose in the strongest possible terms the nomination of Jason Brune to head the DEC. Brune was the spokesman for Pebble Mine and couldn't be impartial if he tried.

We cannot tolerate mining activities to proceed anywhere in our state without the highest levels of oversight and accountability. Already the Army Corps has been so compromised that its draft environmental impact statement fails to consider the most obvious danger associated with Pebble- a catastrophic tailings dam failure similar to the disaster at Mt. Polley in 2014. The company responsible for designing that earthen dam that failed, resulting in the devastating release of billions of gallons of mining waste into nearby salmon streams, is the same company that was hired by Northern Dynasty to design the earthen dams at Pebble. Yet the Army Corps ignores this possibility.

After the Mt Polley disaster, the Auditor General of British Columbia concluded that if the mandate of the regulatory agency included a responsibility to both promote and regulate mining, there is no meaningful oversight. They recommended to the Canadian parliament that they create an independent compliance and enforcement unit for mining activities, with a mandate to ensure the protection of the environment. Likewise, if the DEC cannot be an independent regulatory agency, then they should be demolished and a new agency created with the mandate to protect the environment and hold mining companies to the highest possible standards.

Alaskans demand accountability and fairness at all levels of government and will not tolerate corruption of our public agencies.

I represent myself. I was first given the wrong e-mail and have had to forward. Thank you.

I get that my issue is most likely with Governor Dunleavy's misguided priorities in selecting his leadership, but that ship has sailed. People voted slightly over 51% to elect Dunleavy, after a somewhat chaotic election season. But I can say here and now that it is NOT appropriate for you to approve Dunleavy's selection of Jason Brune. He spent eleven years as an advocate for business through his work with the Resource Development Council. He was welcomed in that job as someone who will "make a difference for business." This is right after he worked for AMEREF where he described himself as an educator. I wonder how RDC got the impression he would be a development advocate; perhaps because his education was NOT balanced. Yes, he worked for CIRI, but it has been clear from many public dialogues on resource protection, the corporations do not always speak for their native constituents who live the subsistence lifestyle.

Mr. Brune has a BS in biology but no Master's Degree to show for his environmental science studies, saying he did some research but was "too busy" to finish. I am afraid that he will be "too busy" to be the watchdog that his position requires. Or maybe he will think it is OK that the developer was "too busy" to complete their plan for mitigation. Or "too busy" to clean up a mess left behind. Conservation means wise use, and the DEC is assigned to consider development, not rubber stamp it.
