Analysis

This bill changes the procedures for members of the Board of Fisheries and the Board of Game when it is determined a member has a personal or financial conflict under AS 39.52. Currently, if a member is found to have a conflict on an individual proposal, that member must physically remove themselves from the deliberations and board actions. This bill would allow the member to remain at the table for deliberations but would still require recusal from actions. This bill does not affect either board's existing authority to determine if a member has a conflict under AS 39.52. None of these changes result in a fiscal impact to the department.
