To Whom It May Concern:

NAMI (the National Alliance on Mental Illness), is the largest grass-roots organization in the country providing education and advocacy for families affected by mental illness. NAMI Alaska is the Alaska state chapter of NAMI. There are nearly 1,000 local NAMI affiliates, nationwide, of which four are in Alaska: NAMI Anchorage, NAMI Fairbanks, NAMI Juneau, and NAMI North Slope. These are volunteer-centered organizations providing classes and support for families impacted by mental illness.

NAMI Alaska supports SB 10 and HB 22, which would extend the "sunset" date of the Alaska Statewide Suicide Prevention Council to 2027.

Alaska, tragically, leads the nation in rates of suicide. We must do what we can to reduce the horrific toll suicide takes on Alaskan families. Suicide is preventable. "Treat the mental illness; prevent the suicide." Like most illnesses, the earlier mental illness is diagnosed and treated, the better the outcome.

Information, and access to resources prevent suicide. The Alaska Statewide Suicide Prevention Council is an inexpensive and effective way to reduce Alaska's rate of suicide. Extending the sunset date – keeping the Council from having to close its doors – is essentially free. Please support these bills. Thank you.

Dear Representative Tarr:

The Alaska Federation of Natives (AFN) writes to express our strong support for House Bill 22, An Act extending the termination date of the Statewide Suicide Prevention Council; and providing for an effective date. We also support the Alaska Native Health Board's (ANHB) efforts to amend HB 22, and its companion bill SB 10, by adding a tribal health representative, which would be nominated by ANHB and its Tribal Behavioral Health Directors Committee.

AFN is the largest statewide Native organization in Alaska. Our membership includes all 12 regional for-profit corporations, all 12 regional non-profit organizations, 171 for-profit village corporations, 191 federally recognized tribes, as well as a number of tribal consortia that contract and compact to run federal and state programs. Our mission is to enhance and promote the cultural, economic and political voice of the entire Alaska Native community. AFN serves as the principle forum and voice of the Alaska Native community in dealing with critical issues of public policy and government, including state legislation.

Suicide prevention, education, and awareness have been priorities of AFN for many years. Our former board member William Martin serves as a Vice Chair for the Statewide Suicide Prevention Council (SSPC). We fully support the continuation of the SSPC, and the work of ANHB.

Alaska Natives and American Indians are the only ethnic population specifically listed as at-risk for suicide by the U.S. Substance Abuse and Mental Health Services Administration (SAMHSA). Since suicide disproportionately affects Alaska Natives and American Indians, AFN fully supports SSPC's continuation, and we see the value of expanding the council to include a subject matter expert in prevention who has program experience in the tribal health system. The individual's knowledge and experience would add tremendous value to the work of the SSPC. Suicide is preventable, and an

additional tribal representative on the SSPC would be a critical resource in providing a unique perspective to promote resiliency and raise awareness.

Dear Legislators,

The Juneau Suicide Prevention Coalition is writing in strong support of House Bill 22 to extend the State Suicide Prevention Council (SSPC) until June 30, 2027. It is critical that the important work of the SSPC be reauthorized and funded throughout this time period.

The suicide rate in Alaska continues to be extremely high. In 2017, Alaska's suicide rate was the second highest in the country. The problem of suicide continues to escalate in our state; our suicide rate increased by 13% in the period from 2012 to 2017. Suicide is the leading cause of death among Alaskans ages 10 to 64, and the sixth leading cause of death overall in our state. Given the severity and magnitude of suicide in Alaska, it is essential that our state continue to dedicate resources to support suicide prevention strategies.

The SSPC has been an excellent resource to help guide statewide suicide prevention efforts, including those efforts by our Coalition in Juneau over the past ten years. The recently revised "State of Alaska Suicide Prevention Plan" 2018-2022, "Recasting the Net – Promoting Wellness to Prevent Suicide in Alaska" provides a framework for suicide prevention from the individual to community to statewide levels. Council members come from a cross-section of our population to ensure representation of different perspectives. The statewide prevention summits the State Council has co-sponsored were especially valuable for building relationships between our widespread communities and fostering collaboration and resource sharing.

Suicide is a complex public health problem. The SSPC has been instrumental in fostering communication to break the silence and stigma surrounding the difficult social problems contributing to suicide and preventing people in distress from receiving the help they need. There are many challenges and much work ahead. The SSPC has built a solid foundation for continuing and expanding the good work of Alaskan communities to find the best ways to nurture healthy citizens who value life and can be part of a healthy Alaska. Please continue to authorize and fund the State Suicide Prevention Council.

ALPHA strongly supports HB 22, to extend Alaska's Statewide Suicide Prevention Council to June 30, 2027. As outlined in Alaska Statute 44.29.350, the functions of the Council are necessary to improve health and wellness throughout the state by reducing suicide and its effects on individuals, families and communities.

The Statewide Suicide Council has done a remarkable job of raising awareness; coordinating and improving statewide prevention programs and resources; collaborating with national, state and local stakeholders and resources; and developing, updating, and implementing statewide prevention plans.
