Dear Representative Stutes,

The Chignik Regional Aquaculture Association ("CRAA") wishes to express its support for the appointment of Marit Carlson-Van Dort to the Alaska Board of Fisheries. CRAA's members include commercial fishermen, subsistence fishermen, seafood processors, sport fishermen, local governments, local Alaska Native corporations, and other individuals and entities with interests in fisheries enhancement activities in the Chignik Management Area. Our permit-holding members all hold permanent and interim CFEC Chignik Salmon Purse Seine Permits.

Commercial fishing is an ingrained way of life for CRAA's members. The Chignik commercial sockeye fishery is wedged in between two larger mixed-stock fisheries, the Kodiak Area fisheries to the east and South Alaska Peninsula fisheries to the west. Its location makes Board of Fisheries decisions about how to best manage mixed-stock fisheries crucially important to CRAA's members.

Subsistence fishing is also tremendously important to CRAA's members who no longer participate in the commercial fishery, or who are unable to participate due to age or physical limitations. These members depend upon the Chignik subsistence fishery to meet their nutritional needs. As sockeye returns have diminished in recent years and the amount necessary for subsistence has been reduced, our members recognize how vitally important the Board's decisions are to the preservation of their customary and traditional ways of life.

The Board's critical role in the management of Alaska's fisheries means that its members should possess the knowledge, experience, and ability necessary to translate complicated information and issues into prudent and effective regulations. CRAA is confident that Ms. Carlson-Van Dort's personal and professional experiences will make her an invaluable asset to the Board and the fisheries management process.

Ms. Carlson-Van Dort's education and professional work in natural resources management and environmental conservation has equipped her with the rare ability to understand the broad environmental effects of fisheries regulations across management areas and ecosystems. As the result of spending over a decade working as a commercial seiner, Ms. Carlson-Van Dort comprehends the intricacies of Alaska's commercial fisheries, and understands the economic and social impacts fisheries regulations have on commercial fleets.

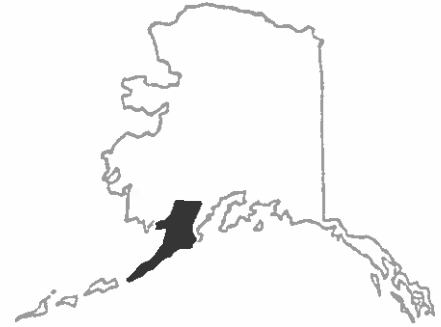
