Regardless of your political party, I ask you to imagine yourself as a member of my family; and to support Alaska's Equality Act, HB 82.

About me: I am a mom, a business-person, and an Alaskan. I grew up here with my dad, a family practice physician, and my mom who stayed at home to raise her kids and volunteered with our local religious organization. Dad taught me and my siblings how to fish, hike, cross-country ski, hunt. He is also private pilot, and my childhood was filled with opportunities to meet people in communities very different from my home town of Anchorage.

Mom raised us to be honest, and hard working. She taught us to love one another and our neighbors, and to have an open heart to those who are different in religion, ethnicity, culture...and to strive for excellence in all pursuits.

I've been happily married for over 21 years. Over those years, I've held various jobs, but none more important than my full-time occupation and vocation: I am a mom. My husband and I raised two children into young adulthood and made Alaska our permanent home. We raised our kids with the same expectations and love which benefitted us growing up,

All things were on track for my kids to be able to do great things - they were healthy, capable kids. But five years ago, my understanding of our family's life and especially the life of my youngest child were changed dramatically, and in a scary way. *And it is still this way every day for families like my own.*

My child is transgender. This is something we've been learning about and dealing with since he found the courage to tell us those years ago. And yes, I was scared, and sad, and confused. But here's the takeaway: I have educated myself extensively about transgender health, experiences, and outcomes. I have, and will continue to do, everything in my power to protect my son's rights to pursue his dreams, and live his life without fear of persecution. He is intelligent, thoughtful, kind, incredibly hard-working, and dedicated. His gender identity affects exactly NONE of those qualities. Yet his ability to live and thrive in our home state is constantly in question. It is time to pass a statewide equality bill to protect all Alaskans. In fact, in refusing to vote on the equality bill the state is actually elevating some people above others. This isn't just, and it isn't right.

The statistics are very clear; trans people experience joblessness, homelessness, violence, and suicide at a staggering higher rate than the rest of the population. And here is what I am asking each of you to really take in; these high rates are NOT because they are trans. It is because society and community has lacked the language, tools, and understanding to accept them and protect them. The equality act doesn't give special privileges to people like my son. It offers a legal protection for him, necessary because the statistics are grim. This

must change!

My transgender child is an educated, capable, and self-confident young person. He is supported, loved, and accepted. Many others in our state are not. Would I choose something different for him? Perhaps - but that is a selfish desire, not one that respects his autonomy and intelligence; and is a wish based in large part by the fear that he will be treated differently. I can put that fear aside and love my kid, and continue to expect him to strive for excellence; and expect that as he does, his opportunities will not be limited simply because of who he is. I expect that the state I love and call home will do the same.

It's time to support the Equality Act, HB 82 and I call on each of you to do so.

I'm writing today to express my strong support for House Bill 82 as proposed by Rep. Josephson, also known as the Alaska's Equality Act. Alaska is one of 30 states without such a law that would protect all LGBT residents from discrimination in housing, employment and public accommodations.

Within the state, LGBT Alaskans have limited protections in these realms in Juneau, Anchorage, Sitka and Bethel. Just recently, we saw Fairbanks debate this issue and it will now go before it's residents as a referendum. We should be focusing efforts on statewide protections for all of our residents, instead of creating a patchwork of legal protections. That only leads to confusion and legal chaos.

Many people don't realize that LGBT people can still lose their jobs, their homes and be denied service in restaurants, hotels, or other public accommodations. It is perfectly legal in much of our state. In the places where some of these types of discrimination are illegal, they are nearly impossible to enforce. For example, in Juneau, it is illegal to fire someone in the private sector because they are gay, but the only option for recourse is a costly lawsuit by the victim. This is not sufficient. A statewide law would provide the prosecutorial support needed to truly enforce these local ordinances that lack teeth.

I'm openly gay, living in Juneau, and I'm watching our community grow larger and larger. This means that there are more people who are vulnerable to discrimination and need protection. We are a community deserving of support as a class of people, similar to those targeted by race, religion, and physical ability.

I urge you to vote to pass this bill out of committee and on to it's next step to passage statewide.
