Please review the Supreme Courts findings in regards to Karl S. Johnstone:

Supreme Court of Alaska

IN RE: the proceeding under AS 22.30.070(c) in relation to Karl S. Johnstone, Petitioner.

No. S-8387.

Decided: May 19, 2000

In summarizing this case; Karl Johnstone was responsible to elect a new Coroner for the Third Judicial District. Johnstone instructed the area court administrator to commence a recruitment process initiating a standard merit process. A merit hire, in contrast to a partially exempt appointment, requires a structured process involving publicity, specific application requirements, deadlines, and assignment to eligibility lists. Thirty-nine individuals had the appropriate qualifications for the job.

After the deadline had passed for qualification, etc. Judge Johnstone received a call from a colleague (Chief Justice Moore) suggesting a Mr. Richard McVeigh might be interested in the job, (however never had experience as a Coroner). Justice Johnstone appointed Mr. McVeigh for the job without even as much as an interview! Thirty-nine individuals had appropriate qualifications for the job, - McVeigh had none!

Supreme Courts Findings: "Here the appearance of impropriety arising from Judge Johnstone's conduct caused harm that is both actual and significant. An appearance of favoritism will always impair the general public's confidence in the judiciary."

My name is Andrew Couch, I own and operate a sportfishing guide business located in the Matanuska -- Susitna Borough. I am also a member of the Matanuska Valley Fish and Game Advisory Committee and the Matanuska -- Susitna Borough Fish and Wildlife Commission -- but am presenting my own personal point of view.

I've been involved in the Alaska Board of Fisheries Upper Cook Inlet meetings since the 1980s. I've written several fishery proposals over time, several of which have been adopted by the Board.

I am a Kenai resident with a lifelong love for both sport and commercial fishing. In addition to my outdoor habits, I am a local small business owner and volunteer on the boards of several local quasi-governmental organizations. I try to stay involved in state and local policy and have developed a number of positive relationships with policy makers. I'm familiar with how an open public process works and am very aware of the benefits our diverse fisheries provide to my local economy. During these times of uncertain state finances, our local resources and industries are increasingly important to my area.

I know your plates are full, and there are many current issues I'd love to bend your ear on, but I felt compelled to write to you today concerning two of the Board of Fish nominees before you whom I have had personal experience dealing with:

I'm very happy to see Israel Payton re-nominated to the BOF. Israel's background differs from mine and we certainly don't agree on everything, nor has he always voted the way I might prefer. That said, every time I've dealt with Israel he has been open, honest, and respectful. He is eager to learn and discuss the issues and always strives to achieve mutually beneficial solutions. He does his homework, asks tough questions, and most of all, he respects the public process while striving to make it better. The employees of ADFG respect him because he respects the science, and they wince when he raises his hand because they expect tough, science-based questions. I encourage you to confirm Israel for continued service on the Board of Fisheries.

Conversely, I was very disappointed to see Karl Johnstone's nomination to the BOF. While he is a very smart and well-studied man, I can say with confidence that Mr. Johnstone is the most unethical person I have ever dealt with in state government. Dear Senator Birch,

I'm writing in support of Karl Johnstone's reappointment to the Alaska Board of Fisheries. Mr. Johnstone is fully qualified for reappointment to the Board of Fisheries (BOF). He has served ably in his previous two terms on the Board, including a full term as chair. His 2012 confirmation hearings for reappointment ran largely uncontested by any stakeholder group after a three-year track record. Public comment attesting to his competence was significant.

Worth particular mention were four stellar public endorsements from fellow Board members. During Mr. Johnstone's 2012 reconfirmation hearing in House Fisheries Committee, then Vice Chair of BOF Bill Brown said of his colleague, "I can give him only the strongest possible recommendation. He comes to meetings extremely well prepared. . . . He is extremely fair. He considers all sides of every issue . . . There are times he's brusque, but he listens to people, and he spends a lot of time with stakeholders. As a chair, he runs meetings efficiently and he does everything to get information and let everyone have their say." Reed Morisky, who currently chairs the Board, offered these thoughts at the hearing: "Karl has proven that his decision-making process is even-handed. I do not consider Karl to be a pro or anti sportfishing Board member, nor a pro or anti commercial fishing Board member. I consider him to be a . . . well considered Board member that takes everyone's background and insight into consideration." Chair Morisky also noted: "He understands and applies the principals of the Alaska Constitution, in the Board of Fish process." Howard Delo, former member of the BOF along-side Judge Johnstone, said, "With his judicial background, I believe, he learned how to cut to the chase, and in deliberations, and sometimes in public testimony, somebody would be talking about something, and he would have an idea of what they were trying to say, . . . and he would immediately cut to the chase and ask a very pointed, direct question, and he [often]did the same with department staff." Mr. Delo concluded, "I think Karl represents exactly what a board member should be doing." John Jensen, chair of the BOF during Mr. Johnstone's interim appointment to the Board in 2008, related his experience at Johnstone's 2009 House Resources confirmation hearing saying, "He's been a delight to work with. He studies and understands the material before the meetings, so he's prepared. He works well with the process . . . He understands the issues well and deals with them in a non-bias way, and supports for the sustainability of the resource."

It seems that Mr. Johnstone weighs each fishery problem in context of equity to fishery participants, and alignment with conservation objectives and state statute. Mr. Johnstone improved

Board process during his tenure as Chair. He conceptualized and helped implement Committee of the Whole, where each proposal was looked at independently by the full board and public, rather than having separate, often simultaneous proposal discussions where the public and Board members could not fully participate. He also helped usher in oversight protocols to prevent misinterpretation of Board intent when codifying Board decisions into regulation. Some may see Karl Johnstone as controversial or bias because of views he's expressed on upper Cook Inlet salmon management, but his insights are not based on favoritism. They are based on state statutes, maximum use consistent with the public interest, and maximum benefit to the people of the state. In Mr. Johnstone's own words, "Management and policy decisions should be made based on science and economics, not politics. Nobody is going away. All have legitimate concerns. Significant economic value is at stake. It is time to get back to work. We must team with the Legislature and the BOF in a productive and constructive manner . . . Agreeing on what is essential to sustain the resource, then determining the "needs" of others vs. the "wants".

I encourage the re-appointment of Karl Johnstone to the Board of Fisheries toward a balanced, informed, and capable Board ready to respond to resource needs and decide equitable allocations between user groups.

I am a Kenai resident with a lifelong love for both sport and commercial fishing. In addition to my outdoor habits, I am a local small business owner and volunteer on the boards of several local quasi-governmental organizations. I try to stay involved in state and local policy and have developed a number of positive relationships with policy makers. I'm familiar with how an open public process works and am very aware of the benefits our diverse fisheries provide to my local economy. During these times of uncertain state finances, our local resources and industries are increasingly important to my area.

I know your plates are full, and there are many current issues I'd love to bend your ear on, but I felt compelled to write to you today concerning two of the Board of Fish nominees before you whom I have had personal experience dealing with:

I'm very happy to see Israel Payton re-nominated to the BOF. Israel's background differs from mine and we certainly don't agree on everything, nor has he always voted the way I might prefer. That said, every time I've dealt with Israel he has been open, honest, and respectful. He is eager to learn and discuss the issues and always strives to achieve mutually beneficial solutions.
