Dear Representative Lincoln:

Growing up in Alaska during territorial years, I and my family enjoyed unlimited recreational fishing throughout the entire state. After graduation from the University of Alaska two years after statehood, I worked my way through law school on drift boats in the Bristol Bay commercial salmon fisheries in Ugashik, Egegik and Naknek.

I have no dog in the fight between the commercial and recreational fishery interests. I have participated in both. What I do have, however, is a strong interest in preserving our fishery resources for our children, grandchildren and future generations of Alaskans.
