FY 2020 Senate Finance Judiciary Budget Subcommittee Close-Out Narrative / April 18, 2019

BUDGET ACTION:

The Senate Finance Budget Subcommittee for the Judiciary held 4 meetings (including closeout) with the Department and analyzed all of the Governor's budget transactions. Following are budget highlights.

Governor's Amended Budget Request:

- Accepted the Governor's Amended Budget Request except for these items:
 - o Items related to re-opening the courts on Friday afternoons, comprised of 15 PFT personnel; administration and support costs; appellate court costs; and therapeutic court costs, were rejected.
- Subcommittee Additions, Reductions and Changes:
 - o No additions were made.
- Other Changes:
 - o No other changes.
- Organizational Changes
 - o There were no organizational changes.
- Intent Language
 - o There was no intent language adopted.

Salary Adjustments:

Governor's amended budget proposal did not include salary adjustments; House CS reflects salary adjustments. Salary adjustment figures are informational only and are based on 3% FY 2020 increases to match negotiated increases to General Government Unit state employees. The correct dollars will be added after close-out in the full Finance committee CS.
